Sub: Diversion of 176.231 ha. of forest land for rehabilitation and up-gradation of Talcher-Duburi-Chandikhol Section of NH-23/200 in Odisha under NHDP-III (Group "C") on BOT basis (Package No. NHDP III/DL 5/09-BOT-"C") in favour of National Highways Authority of India from the existing two lane, intermediate lane and single lane to two/four lane carriage way with paved shoulder and earthen shoulder in Cuttack & Dhenkanal Forest Division coming within the jurisdiction of Angul, Jajpur and Dhenkanal Districts in the State of Odisha.

Sir,

With reference to the correspondence cited above on the captioned subject, it is to inform you that, the Government of India MoEF & C.C, Eastern Regional Office, A/3, Chandrasekharpur, Bhubaneswar-751023 as accorded the principle approval of stage-I approval order for diversion of 176.231 ha. of forest land in favour of National Highway Authority of India (NHAI) for rehabilitation and up-gradation of Talcher-Duburi-Chandikhol Section of NH-23/200 in Odisha under NHDP-III (Group "C") on BOT basis (Package No. NHDP III/DL 5/09-BOT-"C"), out of which the proposed forest area for diversion relating to Dhenkanal Forest Division is 70.870 ha. As per stipulation No.(ii) of the said approval order the cost of NPV of the forest land to be diverted should be deposited as per order of the Hon'ble Supreme Court of India and the guidelines issued there under by the MoEF & C.C from time to time.

The detail of calculation in respect of NPV is furnished below for your ready reference.

1. Forest area in respect of Dhenkanal Forest Division proposed for diversion for Non-forest purpose-70.870 Ha.
2. Density of vegetation -0.5 (Eco value class-1)
3. Demand for NPV-Rs.9,39,000/- x 70.870 Ha. = Rs.6,65,46,930/-

As per stipulation No.(iv) of the said approval order, Compensatory Afforestation shall be raised over degraded forest land identified in Madhi RF over 266.03 Ha. and Anantapur RF over 86.432 Ha. & 267.229 Ha. under Kamakhyanagar West Range of Dhenkanal Forest Division at the cost of User Agency.

In this connection as per stipulation No.(ix) of the said approval order, the User Agency shall transfer the cost of raising and maintaining the Compensatory Afforestation for 10 years at the current wage rate. Accordingly the CA Scheme has been technically approved

by the Addl. PCCF (FD & NO) FC Act O/o the PCCF, Odisha with a financial forecast of Rs.2,93,07,400/- and Additional CA with a financial forecast of Rs.2,79,03,400/- at current wage rate of Rs.280/- per manday.

In view of the above facts, it is requested to deposit the cost of NPV and cost of Compensatory Afforestation with the Adhoc-CAMPA in the savings Bank Account pertaining to the State concerned through the e-payment mode only.

1. NPV = Rs. 6,65,46,930/-
2. CA = Rs.2,93,07,400/-
3. Addl. CA = Rs.2,79,03,400/-



Sir,

With reference to the letter cited above on the captioned subject, it is to inform that the Govt. of India, MoEF & CC vide letter under reference have accorded permission for rehabilitation & up-gradation of Talcher-Duburi- Chandikhole Section of NH-23/200 in Odisha under NHDP-III in favour of NHAI of India of 105.361 Ha. of forest land in Cuttack Forest Divisions for diversion subject to fulfillment of 16 Nos of conditions.

In this connection, for compliance of Condition No. 2, it is requested to pay the Net Present Value (NPV) of Forest area proposed to be diverted under the proposal as per the orders of Hon'ble Supreme Court of India dt. 28.03.2008, 24.04.2008 & 09.05.2008 in Writ Petition (Civil) No. 202/ 1195 & the Guidelines issued vide letter No. 5-3/ 2007-FC dt. 05.02.2009 in this regard.


The NPV amount is Calculated below:-

- (i) The Forest area proposed for diversion- 105.361 Ha.
- (ii) Eco- Value Class-III, density of vegetation below 0.4
- (iii) The NPV to be paid @ Rs. Rs. 6,26,000/- per Ha.= 105.361 Ha. X 6,26,000/- = Rs. 6,59,55,986/-
(Rupees Six Crore Fifty nine Lakh Fifty five thousand nine hundred eighty six) only.

Hence, it is requested to furnish an undertaking to pay the additional amount of NPV if so determined as per final decision of the Hon'ble Supreme Court of India. So, you are requested to make arrangements for payment of the above amount through e-payment module & submit the receipt of the deposition as evidence with UTR No. & date to this office for reference & record.

Besides, you are requested to make point wise compliance of all other condition imposed in Stage-I(in Principle) approval order.
