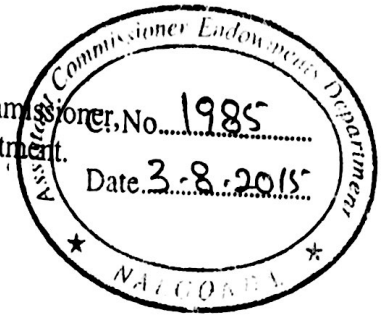

It is informed that the Government of India, New Delhi vide reference cited, has accorded in-principle (Stage-I) approval for diversion of 0.372 Ha of forest land in Nalgonda district for formation of Link Road from existing CC road to Undrugonda Laxmi Narsimha Swamy Temple in Indragonda RF in Nalgonda district in favour of Asst. Commissioner Endowment Department, Nalgonda with certain condition stipulated therein.

As per the **Condition No. iii** : The user agency has to pay the Net Present Value (NPV) of the forest land being diverted under the proposal.

As per the Ecological classification defined by the CEC the area proposed for diversion falls under Eco-class III i.e., consisting of tropical dry deciduous forest and the Eco-value class of the proposed diverted area falls under open Forest category of Eco-value class III. Hence as per the Supreme Court of India order dt: 28.03.2008 and Lr.No. F.No.578/1995/SE/PILC dt: 15.05.2008 the Net Present Value was fixed as 6.26 lakhs per Ha. The total amount to be paid towards NPV comes to **Rs. 2.329 Lakhs @ Rs. 6.26 Lakhs per Ha.**

Hence the user agency is requested to deposit an amount of **Rs. 2.329 lakhs** towards Net Present Value (NPV) in to the Telangana Compensatory Afforestation Fund / Telangana State Compensatory Afforestation Fund Management & Planning Authority(CAMPA). The details of the accounts are as follows.
