ORDER:

Vide reference 1st read above, the Chief engineer / construction, Bhadradri Thermal Power Station, Manuguru has submitted proposal stating that Consultancy services for preparation of detailed project report for feasibility of Railway Marshalling Yard with suitable railway tract from Manuguru Railway station to BTPS Project site was awarded to M/s RTTLS Limited, their feasibility report the alignment has been finalized with 17.20km length and requirement of land is Ac:171.19gts.

Vide reference 2nd read above, the Chief Engineer, BTPS, Manuguru has submitted a report stating that an extent of Ac. 64-10 gts of Forest land was diverted towards laying of Kailway line from Manuguru Railway station to Bhadradri Thermal Power Station, Manuguru and requested to identify Govt land to an extent of 26.00 Ha (Ac. 64-10 Gts) in any Mandal of Bhadradri Kothagudem district for favour of arranging CA lands to Forest Dept in lieu of diversion of Forest land.

Further he stated that, TS GENCO will arrange their own land to an extent of Ac:18-35 grs available adjacent to ash pond area under construction at BTPS, Manuguru towards part of A land, in lieu of proposed diversion of forest land—to an extent of Ac:64-10gts(26-001la) required for laying of Railway line from Manuguru Railway station to Bhadradri Thermal Power Station, Manuguru.

Vide reference 3rd read above, the District Forest Officer, Bhadradri Kothagudem has submitted a report and stated that, there is an extent of around Ac:70-00 gts of revenue land in the Sy.No:28 of Ulvachelaka Revenue Village(deserted village) of Allapalli Mandal which was identified for compensatory afforestation in lieu of diversion of forest land for construction of fundala Nimmavagu Project in 2005 at Gundala Mandal, but clearance had not come and the proposal was lapsed. In view of the above the same land may be considered for Non-forest empensatory afforestation in lieu of diversion of forest land of 25-8435(Ha) for laying of Cailway line from Manuguru Railway station to Bhadradri Thermal Power Station, Manuguru in favour of TSGENCO.

Vide reference 4th read above, the Collector & District Magistrate, Khammam has bereby ordered to transfer the non- forest land identified in Sy.No:28 to an extent of 19-82 Heets of Gevernment land situated ate Ulvachelaka village of Gundala Mandal for raising compensatory afforestation in lieu of the land coming under sub- mergence ic 19-82 Heets for construction of tank across Nimmavagu Project of Muthapuram Village of Gundala Mandal to be the department. Further instructed to Mandal Revenue officer, Gundala is directed to take munediate action for above matter and make necessary changes in the Revenue Record infinediately.

In this regard, the Mandal Revenue Officer, Gundala has handed over the Government and to an extent of Ac:70-00gts in Sy.No:28 situated at Ulvachalaka Village of Gundala Mandal of Sri M.V.N. Seetha Rama Rao, Forest Ranger Officer on 15.02.2002 under cover of Panchinama in lieu of diversion of forest land for construction of tank across Nimmayagu Project of Muthapuram Village of Gundala Mandal to Forest department

In light of above, the Govt land to an extent of Ac. 46-00 gts is hereby proposed towards Compensatory Afforestation lands in lieu of Forest lands taken towards laying of Railway line from Manuguru Railway Station to BTPS, Manuguru.

The District Forest Officer, Bhadradri Kothagudem is requested to take over the aforesaid CA Lands from the Tahsildar, Allapally immediately and the Tahsildar, Allapally is requested to Nominal possession handover the aforesaid land to the District Forest Officer, Bhadradri Kothagudem and incorporate changes in Revenue records in favour of Forest Dept and report compliance.
