TO WHOMSOEVER IT MAY CONCERN

In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No. 11-9/98 FC(pt) dated 3rd August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (TRA, for short) on the forest land proposed to be diverted for non-forest purposes, it is certified that **4.25 hectares** of forest land proposed to be diverted in favour of **Government Medical College Haldwani (Department of Medical Education, Government of Uttarakhand)** for establishment of "State Cancer Institute" (with expansion of Swami Rama Cancer Hospital Haldwani) and "Infection Disease Hospital" in Nainital district falls within jurisdiction of **Ward-53 Mukhani Third (Haripur Sukha) in Haldwani** tehsil.

It is further certified that:

- (a) the complete process for identification and settlement of rights under the FRA has been carried out for the entire 4.25 hectares of forest area proposed for diversion. A copy of records of all consultations and meetings of the Forest Rights Committee(s) Ward(s), Sub-Division Level Committee(s) and the District Level Committee are enclosed as annexure at form- 23.2 and 23.3 of this proposal.
- (b) The proposal for such diversion (with full details of the project and its implications, in vernacular (local language) have been placed before each concerned Ward of forest dwellers, who are eligible under the FRA.
- (c) The each of concerned ward(s), has certified that all formalities/processes under the FRA have been carried out and that they have given their consent to the proposed diversion and the compensation and ameliorative measures, if any, having understood the purpose and details of proposed diversion. A copy of certificate issued by the Member of Ward-53 Mukhani third (Haripur Sukha), Tehsil- Haldwani, District- Nainital (Uttarakhand) is enclosed at Form- 23 to 23.1.
- (d) The discussion and decisions on such proposals had taken place only when there was a quorum of minimum 50% of the members of Ward were present.
- (e) The diversion of forest land for facilities managed by the Government as required under section 3(2) of FRA have been completed and the Ward have given their consent to it.
- (f) The rights of Primitive Tribal Groups and Pre-Agricultural Communities, where applicable have been specifically safeguarded as per section 3(1)(e) of FRA.
