

Transfer of Certificate issued under Forest Rights Act 2006 for diversion of forest land of 101.83 Ha for Open Cast Mining in the Gangaramchak & Gangaramchak – Bhadulia Coal mine, in the mouzas Gangarampur (JL No. 62), Bastavpur (JL No. 59), Bhadulia (JL No. 58), Sahebpur (JL No. 57) and Ahamedpur (JL No. 56), P.S Khoirasol, District, Birbhum from M/s Bengal EMTA Coal Mines Ltd to M/s The West Bengal power Development Corporation Ltd. (WBPDCCL)

The Gangaramchak & Gangaramchak – Bhadulia Coal mine, Birbhum has been allocated to WBPDCCL by the Ministry of Coal, GOI after de-allocation of coal blocks by the Hon'ble Supreme Court of India on 1st April 2015. As per the allotment order which was issued by the Ministry of Coal based on the Coal Mines Special Provision Act 2015, and approvals, if already issued by the State Government to the prior allottee.

In pursuance of the above, the Certificate issued earlier to Bengal Emta Coal Mines Ltd under Forest Rights Act, 2006 by the District Magistrate & Chairman District Level Forest Rights Committee, Birbhum (no.1274/BCW/Birb. 

C E R T I F I C A T E

This is to certify that the process for identification and settlement of rights under the Forest Rights Act, 2006 has been carried out for the entire forest area having 101.83 Hectares of forest land proposed for diversion for non-forest purpose (Open cast mining project) by Bengal EMTA Coal Mines Ltd. in mouzas Gangarampur (J.L.NO.-62), Bastavpur(J.L.No.-59), Bhadulia (J.L.No.-58), Sahebpur (J.L.No.-57) and Ahamedpur (J.L.No.-56), P.S.:- Khorrasole, in the district of Birbhum by the concerned Gram Sabha and Block Level Forest Rights Committee and it has been found that there is no existence of any Scheduled Tribe and / or other traditional Forest Dweller etc. entitled for rights under "Schedule Tribes and Other Traditional Forest Dwellers" (Recognition of Forest Rights) Act, 2006 and that no claimant has applied for such rights.

It is also certified that both Gram Sabha and Block Level Forest Rights Committee (with a quorum of minimum 50% of members) have given their consent to the proposed diversion of forest land for non-forest purpose (Open cast mining project).

Hence the undersigned has no objection for diversion of forest land for non-forest purpose (Open cast mining project) by Bengal EMTA Coal Mines Ltd. in the proposed area as mentioned above.
