Sir,

I am directed to refer to your letter No.SJVNL/LHEP/LA/17-83-84 dated 29.03.2017 and to enclose herewith a copy of letter No.Rev-D(G)10-3/2017 dated Nil received from Member Secretary (SIAU) cum-Deputy Secretary (Revenue) to the GoHP alongwith its enclosures on the subject cited above and to say that on the procedure mentioned under rule 3 (1) of the aforesaid Rules the State Government shall issue a notification for carrying out Social Impact Assessment in accordance with Part B of FORM-1 of these rules regarding the commencement of Social Impact Assessment and the same shall be made available in both Hindi and English to the concerned Panchayats or Municipality or Municipal Corporation as the case may be, and in the concerned offices of the District Collector, the Sub Divisional Magistrate and the Tehsil. A wide publicity will also be made in the affected area through publication in at least two daily newspapers, circulated in the area and also by affixing the notification at conspicuous places within the affected areas. Besides this, the notification shall also be uploaded on the website of the State Government.

Provided that such notification shall be issued within thirty days after the deposit of the processing fee for carrying out Social Impact Assessment by the Requiring Body.
