#### ORDER

In order to co-ordinate and expedite various activities of land acquisition, compensation, forest clearance and issues on Right of Way (ROW) for the on-going Central Project 'Comprehensive Scheme for Strengthening T&D Systems in Arunachal Pradesh' being implemented by PGCIL, District Level Steering Committees (DLSCs) are hereby constituted with the following members.

District Level Steering Committees (DLSCs) shall undertake the following functions with immediate effect:-

1) Maintenance of general law and order for implementation of the Scheme.

2) Conduct district level co-ordination meetings to remove any co-ordination constrains and gaps in the process of implementation of the scheme in the following areas:-

- a. Identification of land and its acquisition.
- b. Matters of Right of Way (RoW).

c. Compensation of land, crops, afforestation, etc. as per, MOU.

3) DLSC shall co-ordinate and report progress to the State Project Implementation Unit (SPIU), constituted by the government, under the Chairmanship of the Chief Engineer (P), Transmission, Planning and Monitoring Zone, Department of Power, Itanagar, as the State Nodal Authority.
