With reference to above mentioned subject, we want to convey that our firm M/S Mandavgarh Hotel Pvt. Ltd. in a joint venture with Govt. of Madhya Pradesh on Public Private Partnership (PPP) model, is setting up a Resort in village Sulibardi, Mandu. It is a government of Madhya Pradesh initiative to promote tourism in the region.

For water requirement to develop the project, Madhya Pradesh Tourism Board (MPTB) has provided for an open well facility in nearby Malipura Village as there is no availability of water on site location. We are required to lay pipeline from open well in Malipura to resort location in Sulibardi Village.
