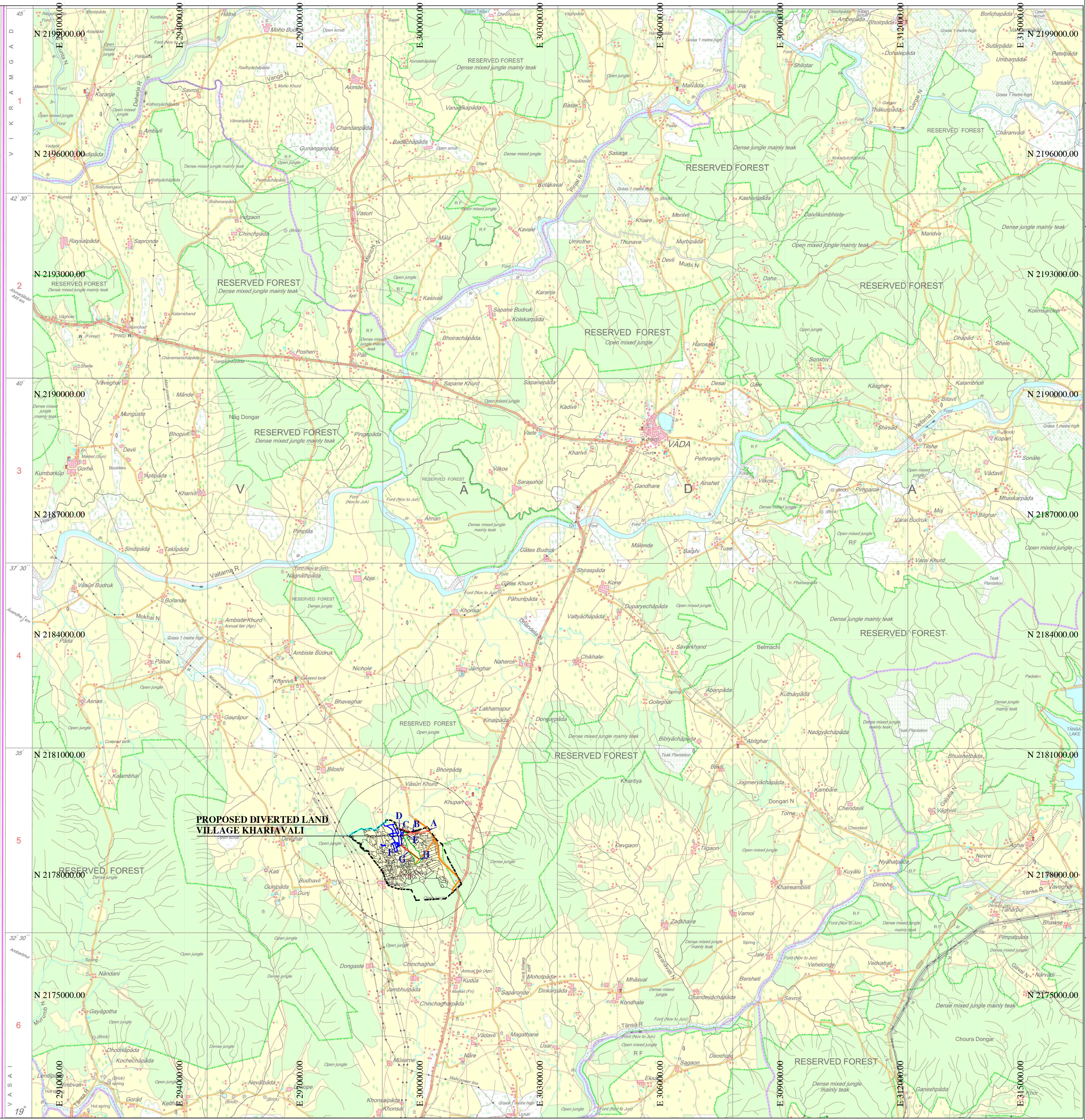
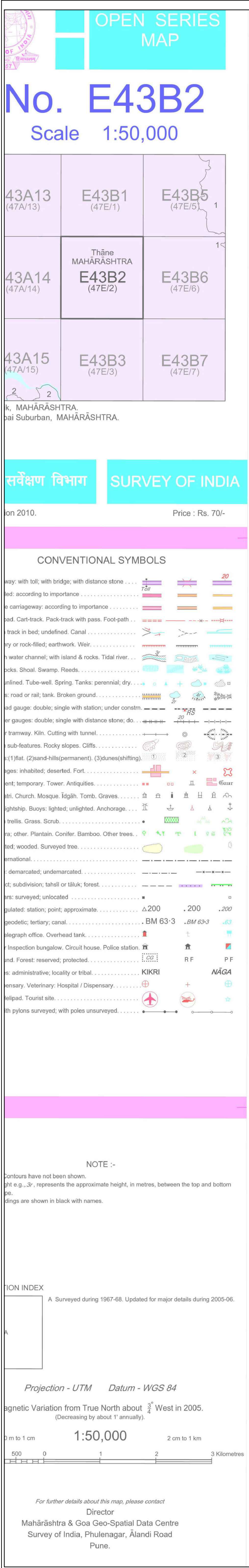




MAP SHOWING LOCATION OF
