2. The Governor of Haryana is pleased to accord administrative approval amounting Rs. 198.65 Lac (Rs. One Crore Ninety Eight Lac and Sixty Five Thousand Only) for improvement of Haily Mandi-Farrukh Nagar via Mechana from km. 16.775 to 17.275 passing through Farrukh Nagar Town in Gurgaon District (Road ID 3131).
3. The administrative approval is subject to condition that the expenditure on the work met during the current financial year i.e. 2015-2016 as well as its above mentioned requisite amount to be adjusted within the approved/revised ceiling of Annual plan 2015-2016.
4. The expenditure involved is chargeable to the Major-Head 5054- R&B, (Plan)-04-0337-98-99-51-16- Construction stg./wdg. and bye pass of roads for State Scheme and total expenditure under it should not exceed the amount that has been placed at your disposal during the current financial year 2015-2016.
5. The technical sanction of this work shall precede actual execution. No work shall be allowed to be taken up in anticipation of technical sanction. The competent authority to issue technical sanction shall be responsible in case of violation of this clause 9.5.1 of the Haryana PWD code.
