READ: Application presented on 22.8.64 by M/s. Orissa Mining Corporation Ltd. for grant of a Mining Lease for Iron ore, over an area of 338.50 hectares hereafter verification came to 403.086 hectares in village Rentha in the district of Sundargarh.

O R D E R :

Whereas M/s. Orissa Mining Corporation Ltd have applied to the State Government for grant of a Mining Lease by their application read above;

Whereas after excluding overlappings of the lease hold of the applicant, only an area of 347.142 hectares in available for grant.

Whereas the mineral in the land in respect of which the mining lease has been applied for belongs to Government and the land is at their disposal;

Whereas the applicant holds a valid certificate of approval from the State Government ;

Whereas the applicant being a limited company is incorporated in India ;

Whereas the applicant by himself or with any person joint in interest with him does not in respect of Iron or related group of minerals held such area in the State as with the area over which the mining lease has now been asked for will exceed ten square miles in the aggregate ;

Whereas the Government of India have conveyed their approval to the grant of M.L. under Section 5(2) of the Mines and Minerals (Regulation & Development) Act, 1957, and also in exercise of the powers conferred by Section 30 of the said Act, directed the State Government to take into consideration this application and pass orders thereon not later than 30.9.65.

Whereas the party was asked in Mining and Geology Department letter No.5583 MG. dated 12.7.65 to indicate his willingness to accept the terms and conditions under which the Mining lease was proposed to be considered for grant and the party in his letter No.1385/OMC/65 dated 31.7.65 agreed to abide by these conditons ;

And whereas the State Government do not consider it expedient to reserve these areas for exploitation by the State, the State Government are hereby pleased to order that a Mining Lease in respect of the available area of 347.142 hectares be granted to Messrs. Orissa Mining Corporation Ltd, subject to the conditons laid down in the State Government letter No.5583 MG dated 12.7.65. The party should comply with all the terms and conditons including furnishing of a surveyed map and description within 3 months from the date of this order to the Collector, Sundargarh.
