Ref: Your appointment letter as Vicar (Prot. No. ES/TA/3574 dt. 24-01-2019) & Your appointment letter as Vice-Rector (RM/KMDY/9 dt. 09-02-2019)

By the above mentioned appointment letters, you, Fr. Varghese Manavalan, are both the Vicar of St. Thomas Church, Malayattoor and Vice-Rector of International Shrine, Malayattoor - Kurisumudy. At present the position of the Rector of International Shrine, Malayattoor - Kurisumudy is vacant. In the absence of the Rector, as per the bye-law of the Kurisumudy (Article III d & Article VII, No. 1) and as per the appointment letter given to you as Vice-Rector, you discharge the duties and responsibilities of the Rector.

The landed property having an extent of 9.7096 Hecters at Mannarkad Taluk, Agali Village (Sur. No. 742/15) belonging to the International Shrine, Malayattoor - Kurisumudy is administered by you in your capacity as the Vice-Rector of the International Shrine, Malayattoor-Kurisumudy in the absence of the Rector. I hereby authorize you to transfer the aforementioned property to the Forest Department of India, and to execute and register the necessary documents for the said purpose and also to receive in compensation the release of the forest area at Kurisumudy Adivaram for specified needs pointed out in the sketch and for the road (and other facilities) that leads to the International Shrine Malayattoor-Kurisumudy and the Pilgrim Centre, which are situated in the landed property, in the name of Fr. Vicar and trustees of St. Thomas Church, Malayattoor, at Aluva Taluk, Malayattoor Village (Sur. No. 67/1, Area: 5 Hecters and 19 Are), on behalf of the International Shrine Malayattoor-Kurisumudy.
