Note Containing Justification for Locating the Project in Forest Land

Introduction: Indian Oil Corporation Limited (A Government of India Undertaking) was incorporated for smooth implementation of City Gas Distribution (CGD) projects. Indian Oil Corporation Limited (IOCL) has been granted authorization by Petroleum and Natural Gas Regulatory Board (PNGRB) for laying, building, operating and expanding City Gas Distribution Network, Which includes setting up CNG (Compressed Natural Gas) stations and PNG (Piped Natural Gas) connections in authorized Geographical Area of Saran, Muzaffarpur, Samastipur and Vaishali Districts vide authorization dated 29.03.2019.

Indian Oil Corporation Limited is implementing CGD project in Geographical area of Saran, Muzaffarpur, Samastipur and Vaishali Districts along with various other cities of country under the Petroleum and Natural Gas Regulatory Board (Authorizing entities to Lay, Build, Operate or Expand City or Local Natural Gas Distribution Network) Regulation - 2008.

Justification: This Being a City Gas Distribution Project, the natural gas pipeline network will connect major demand centers in city for domestic connection and CNG retail outlets. Natural Gas Pipelines has to be laid along the roads in the city. The network is starting from City Gate station and has to reach the city via shortest routes along the road. Various sections of pipelines come under protected forest in Saran district, the said proposal is required to be applied for. There is no other alternative to the mentioned Pipeline sections in Saran district, which is required to design city gas distribution network in the city.
