1. For Public welfare schemes of the non commercial Government Ventures like school, Rain water harvesting, Tanks, Sewer lines, Village Roads, which are meant for Public Welfare, the NPV may not be charged and that in case it is finally decided by the supreme Court such Projects are not exempt from payment of NPV the user agency, PMU Rhenock, NHIDCL will pay the amount of NPV as determined and order of supreme court.
2. NHIDCL, hereby give an additional undertaking that incase of any upward revision of rate of NPV (as per the report of Expert Committee Constituted by the Supreme Court and the final decision in this respect by the Supreme Court) the Department shall pay the amount of differential NPV.
