SUBJECT – Brief note with respect to Kakri Project of Northern Coalfields Limited (A subsidiary of Coal India Limited – A Govt. of India Undertaking) situated in Tehsil Duddhi, District - Sonbhadra Uttar Pradesh

Brief Description of Project - Kakri Opencast Project is an Open Cast Coal Mine under Northern Coalfields Limited and lies in UP Block of Singrauli Coalfield, Dist. - Sonbhadra, UP. It is located in the north of existing Bina Extension Project of Northern Coalfields Limited. Kakri OCP obtained Environmental Clearance for 2.50 Mtpa production in 1989. The project further obtained EC for revised production of 3.00 Mtpa in 2005 and that for 4.00 Mtpa in 2007. Mining is done in 3 seams namely Purewa Top, Purewa Bottom and Turra. While coal is extracted with the help of Diesel Hydraulic Shovel - Dumper combination, OB removal is being done with the help of Electric Rope Shovel – Dumper combination.


Details of Forest Clearance – Kakri Project comprises of 185.84 hectare Forest land within its lease hold area. Forest Clearance was granted to the project vide letter no: 8-350/87 FC dated 30.05.1989 for a duration of 30 years.

Justification for locating the project in Forest land – The location of any mining project is governed by the location of mineral. Most of the coal bearing area of Kakri Project lies within this forest land. There is coal worth 4-5 years still remaining in this land i.e upto 2021-22 whereas the lease is valid only till 2019. Moreover, a part of this land is also proposed to be transferred to Bina – Kakri Amalgamation Project which is also under Northern Coalfields
