The State Government shall charge the Net present value of the forest area diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India, dt.28.03.2008 and 09.05.2008 in IA No.826 in 566 WP (C) N:202/1995 and as per the guidelines issued by Government of Andhra Pradesh vide Go.Ms.No.124, EFS&T(For.I) Department, dt.27.07.2010.	The User agency shall deposit the NPV of <b>Rs. 18.154 lakh</b> (6.26 lakh per ha.). The amount shall be deposited in CAMPA account through online.
2.	The cost of harvesting of the trees in the diverted forest area. In addition to payment of NPV and cost of harvesting of the trees the following conditions are imposed in – principle (Stage-I) approval to attend by the User agency for submitting the proposals for according Stage-II clearance.

- 1. The demarcation of the forest area proposed for diversion shall be carried out by erecting cement concrete pillars duly numbered at an interval of 20 meters at the cost of user agency.
- 2. To furnish an undertaking agreeing to pay Additional amount of the Net Present Value (NPV) of the diverted forest land, if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future.
- 3. The user agency is also requested to fulfill the other conditions as per the instructions of the G.o.I, MoEF & C.C, letters Dated.13.05.2011, 16.6.2011 and 10.12.2012 shall also be complied with the Principal Chief Conservator of Forests(HoFF), Andhra Pradesh, Guntur and User agency with which they are concerned.
