Sub:- Grant of Mining Lease.

Read:- Application presented on 19.10.93 by M/s Ferro Alloys Corporation Ltd. for grant of Mining Lease for Chromite over an area of 1261.476 hec. in village- Kalarangiata, Ransol etc. in the District of Jajpur.

Order : Whereas M/s Ferro Alloys Corporation Ltd. have applied to the State Govt. for grant of Mining Lease by their application read above ;

And whereas the State Government vide letter No.VI-SM-40/96-5496, dated 24.6.97 have recommended the above application to Govt. of India to accord their approval U/S-5(1) of M & M (D&R) Act.1957 for grant of Mining Lease over an area of 39.318 hec. among other applications.

And whereas the Govt. of India in their letter No. 5/37/97 M.IV, dt.16.4.99 have conveyed their approval to the grant of Mining Lease over 419.181 hec. which includes 39.318 hec. of M/s FACOR Ltd. under section 5(1) of M&M(D&R) Act, 1957 ;

And whereas the applicant was asked in this Deptt. letter No. 12424/SM dt. 3.11.2001 to accept the terms and conditions under which the ML was proposed to be considered for grant and the party in their letter No. 1777 dated 6.11.2001 accepted those conditions;

And whereas the applicant company subsequently represented on 18.6.2004 to split up the proposed mining lease area of 39.318 hec. into two separately blocks i.e. Block-I- 23.800 hec and Block-II- 15.518 hec.;

And whereas the State Government vide this Department letter No.6028/SM, dt.10.6.2005 have accepted the proposal of the applicant ;

And whereas the applicant company have submitted the approved mining plan over an area of 23.800 hec. for issue of grant order;

And whereas the grantee company vide their representation dt.4.4.07 have represented that they do not require 15.518 hec. of land (Block-II second split area) as the said land is non mineral bearing area and they have further requested vide the said letter to restrict the area for lease execution to 23.800 hec. (Block-I only). They have also given undertaking through the same letter that they will have no claim for 15.518 hec. or any other area in lieu of this in future;


Therefore, in supercession to earlier order No. 6028/SM dot. 10.6.05 State Govt. after careful consideration of the above representation of the applicant, hereby pleased to order that Mining Lease in respect of the area over 23.800 hecets. in village- Kalarangiata, Ransol etc. in the district of Jajpur for Chromite be granted to M/s Ferro Alloys Corporation Ltd. for a period of 30 (thirty) years subject to the conditions laid down in the State Govt. letter No.12424/SM,dated 3.11.2001 along-with a condition that the land recorded as "Rasta" shall continue as such and its use by the grantee shall not infrng the existing communal rights of the locality.
