It is informed that the Government of India vide reference 2nd cited has conveyed central Government in-principle (Stage.I) approval under section 2 of Forest (Conservation) Act 1980, for diversion of forest land to an extent of 2.325 Ha (Mahadevpur Division 1.298 Ha + Bhupalpally Division 1.027 Ha) of forest land in Jayashankar District, for laying of pipe line and construction of structures for Segment-15/3 (Mahamutharam), for providing drinking water under Telangana Drinking Water Supply Project, in favour of Superintending Engineer, TDWSP Circle, Karimnagar, subject to compliance of conditions stipulated therein and the Prl. Chief Conservator of Forests, TS, Hyderabad in the reference 3rd cited above has requested to raise the demand note to the user agency for deposition of funds. The details are as follows.

NOTE: Based on the oral instruction of Addl. Pri. Chief Conservator of Forests, FCA, TS, Hyderabad the amount of engaging of protection watchers has to be met from the NPV amount, accordingly the demand notice needs to be revised. Engaging protection watchers as mentioned in part-II will be met by the amount raised NPV.

As per the guidelines issued by the MoEFF&CC, GoI (Ad-hoc CAMPA Wing) remittance for compensatory levies shall be through e-payment portal of Ministry of Environment, Forest & Climate Change only. Further the Pri. Chief Conservator of Forests, TS, Hyderabad reference 3rd cited above has issued instructions that, the charges for felling, logging, transportation of project affected tress and the funds towards expenditure like boundary walls, stone pillars, demarcation charges etc., should be deposited with the Divisional Forest Officers (now DFOs/FDOs) concerned and the work should be undertaken departmentally in order to ensure that the task of felling / transportation / stone pillars etc., The details are as follows.

The Superintending Engineer, TDWSP Circle, Karimnagar is requested to upload the demand online on Ministry's portal, generate Challan & transfer the funds through online only into the specified Ad-hoc CAMPA account of Telangana State. The detailed procedure for generation of Challan and deposition of funds is available at www.forestsclearance.nic.in portal.

Further, the Superintending Engineer, TDWSP Circle, Karimnagar is requested to comply with the following in accordance with the instructions issued by the GoI, MoEF&CC, New Delhi vide F.No.7-23-2012-FC, dated 24.07.2013.

1. Publish the entire forest clearances granted in verbatim along with the condition and safe-guards imposed by the central government in two widely circulated daily news paper one in vernacular language and the other in English granted to the project proponent for the use of forest land for the non-forest purposes.
2. The copies of the forest clearance should also be submitted to the heads of local bodies, Panchayats and Municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days from the date of receipt of this reference.

The transfer of forest land to user agency shall not be affected prior to the issue of final approval (or) working permission whichever is earlier.


