KNOW ALL MEN BY THESE PRESENTS that we **Vapi II-North Lakhimpur Transmission Limited** a company incorporated under the provisions of the Companies Act, 2013 and having its registered office at F-1, The Mira Corporate Suites, 1 & 2 Ishwar Nagar, Mathura Road, New Delhi - 110065, India, hereinafter called "**the Company**" in exercise of the powers conferred by the Board of Directors vide resolution dated 10th August, 2020 and Company's Articles of Association and of powers enabling the company in that behalf doth hereby constitute and appoint:

In case any of the Attorney's ceases to be in the employment of the Company, then the rights to such attorney under this instrument will extinguish forthwith

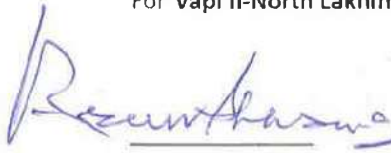
