
It is further certified that:-

The proposed area of diversion in Penukonda RF Penukonda Range in Anantapuramu District does not fall in the Scheduled Tribe Area and therefore does not attract the provision of ROFR Act 2006. Consequent on which identification and settlement of rights under FRA does not arise.
B	A letter from the State Government certifying that proposals for such diversions (with full details of the projects and its implications in vernacular / local languages have been placed before each concerned Gram Sabha of Forest dwellers, who are eligible under the FRA .	There are no Forest dwellers in the proposed diversion area, Hence does not arise.
