With rereference to the above subject, the Ministry of Environment, Forests and Climate Change, Bengaluru has accorded 'in-principle' approval (Stage-I) under Section-2 of Forest (Conservation), Act-1980 for diversion of 5.71 ha of forest land for widening of existing approach road in M.L.No.1111, S.M.Block Sandur in favour of M/s, National Minerals Development Corporation Limited, Donimalai, Sandur vide letter under reference(1). In this regard, the undersigned has already submitted the compliance report to conditions stipulated in the Stage-I approval accorded by the Government of India vide letters under Ref(3).

Conservator of Forests (Forests Conservation) & Nodal Further, Principal Chief Officer(FCA), Bengaluru has directed the undersigned with an instruction to submit the compliance to mentioned points and issue Supplementary Demand Notice for recovery of differential CA and PCA charges vide letter under Ref(2).

As per directions of the Principal Chief Conservator of Forests (Forests Conservation) & Nodal Officer(FCA), Bengaluru, the differential CA charges as applicable for the above referred proposal are calucalated as here under;
