



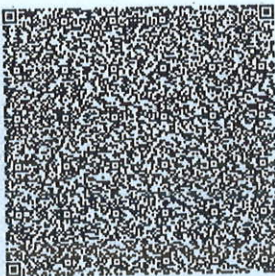

In case the Attorney' ceases to be in the employment of the Company or any of its associated/ group Company, then the rights to such attorney under this instrument will extinguish, forthwith.

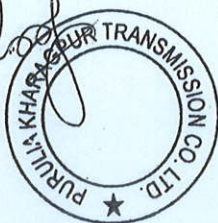


