In inviting a kind reference to the memo on the captioned subject, it is to inform you that the financial outlay of the scheme for Compensatory Afforestation and creation and maintenance of plantation of dwarf species in RoW against the diverted forest land pertaining to above project has been revised due to enhancement of wage rate i.e. @333/- Manday.


Accordingly the financial outlay for Compensatory Afforestation scheme has been approved by Principal Chief Conservator of Forests (Forest Diversion & Nodal Officer, FC Act vide his memo cited under reference and Divisional Forest Officer (T) Nabarangpur has revised and approved the dwarf plantation Scheme considering plantation of 18 month old seedlings as it has been decided to plant 18 month old seedlings in the plantation henceforth basing on the

current wage rate i.e. @ Rs.333/- manday & the cost of the proposed CA and plantation of dwarf species has been revised & calculated which comes to Rs. 1,94,72,200/- & Rs.1,49,04,209/- respectively as detailed below.




