As per the Principal Chief Conservator of Forests (HoD) reference 2nd cited above, approval (Stage I) was issued in the reference 1st cited, under section 2 of Forest Conservation Act, 1980 for the diversion of 0.678 Ha of forest land in Mahaniyam RF for relaying and periodical maintenance of Mahaniyam to Padappai road subject to the following conditions.

1. As per condition in Para (ii) the demarcation of the proposed forest land shall be carried out the User agency by erecting 4 feet high cement concrete pillars duly numbered at an interval of 20 meters at their cost.

2. As per condition in Para (iii) in the reference 1st cited, fresh plantation has to be raised in 1.436 Ha of degraded forest area of Maganiyam RF of Sriperambudur Range at the project cost. Accordingly for 10 times the number (8) standing trees to be felled raising the fresh plantation 80 trees and raising the fresh plantation 1356 trees maintenance for a period of 10 years, an amount of Rs.28,27,790/- (Rupees Twenty Eight Lakhs Twenty Seven thousand Seven hundred and Ninety Only) is arrived and user agency is requested to remit this amount under State CAMPA account.

3. In respect of condition in Para (iv) NPV of the diverted forest area to be paid. It is informed that at the rate of Rs.6,70,140/- Lakhs per ha (as per the guidelines of the Government of India, Ministry of Environment Forest and Climate Change, New Delhi letter File. No.5-3/2011-FC (Vol.I) dated.06.01.2022) the total cost of NPV for 0.678 Ha has been arrived Rs.4,54,355/- (Rupees Three Lakhs Twenty Eight thousand Three hundred and Eighty Nine only) and the same has to be remitted under the State CAMPA account.

4. As per condition Para (vi) It is requested to remit an amount of Rs.32,82,145/- (Rupees Thirty Two Lakhs Eighty Two thousand One hundred and Forty Five Only). (Rs.28,27,790+4,54,355) under the State CAMPA by generating an online challan for making payment to through e-portal (https://parivesh.nic.in/);

5. As per condition Para (vii) the user agency is requested to obtain permission from the hon'ble Supreme Court of India for felling of spontaneous tree growth in the forest area proposed for diversion for the project.
