With reference to 1st cited above, Government of Andhra Pradesh has accorded in-principle (stage-I) approval for the subject mentioned diversion proposal.

Adverting to the demand notice issued by your office for payment of NPV, challan with acceptance of nodal officer has been generated and an amount of Rs.4,08,654/- has been remitted to ANDHRA PRADESH CAMPA, Corporation Bank account on 31.03.2017.

Further vide ref 4th cited ,demand notice issued for payment of tree extraction charges and CA amount for raising avenue plantation by your office. The payment of tree extraction charges for an amount of Rs.1,18,182/- made through demand notice in favour of Divisional Forest Officer ,SPS Nellore and the same was confirmed by you vide ref 5th cited. The CA amount for raising avenue plantation was accepted by Nodal Officer and Challan was generated and amount of Rs.2,01,863/- has been remitted to ANDHRA PRADESH CAMPA, Corporation Bank account on 29.05.2017
