कृपया प्रकरण में भारत सरकार, पर्यावरण एवं वन मंत्रालय, नई दिल्ली द्वारा पत्र क्रमांक/ 8-47/2017-FC दिनांक 03/1/2018 से जारी प्रथम चरण सैद्धांतिक स्वीकृति में अधिरोपित शर्तों का पालन प्रतिवेदन वेस्टर्न कोल्फील्ड्स लि. द्वारा अपने पत्र दिनांक 21/12/2020 से प्रस्तुत किया गया है जिसका संक्षिप्त विवरण निम्नानुसार है:-

Besides this afforestation on degraded forest land to be selected elsewhere measuring one and a half times the area under safety zone shall also be done at the project cost. 

The User Agency shall regularly undertake desilting of these village tanks and other water bodies so as to mitigate the impact of siltation of such tanks/water bodies. (b) Take immediate measures for planting in the same area or any other area selected by the Controller General or the authorized officer not less than twice the number of trees destroyed by reason of any prospecting or mining operations. 
