





Scheme for Creation and Maintenance of Dwarf Species Plantation (Preferably Medicinal Plants) in the right of way under the Transmission Line i. e. "Diversion of Forest Land over an area of 136.966 Ha. (Baliguda Forest Division - 94.013 Ha + Kalahandi North Forest Division - 42.953 Ha) for construction of 220/132/33 KV DC Transmission Line from existing 220/132/33 KV Grid Sub-Station at Kesinga of Kalahandi District to proposed 220/132/33 KV Grid Sub-station at Sirtiguda in Kandhamal District.

1. Total length of Transmission line passes through Forest land of Kalahandi North Division = 12.272 km.
2. Total length of Transmission line available for taking up Dwarf plantation (After deducting area of tower) = 11.232 km
3. No. of rows per kilometer = 8
4. Total No. of Seedlings to be planted =  $8 \times 250 \times 11.232 = 22464$
5. Total No. of Seedlings to be planted (Including 1<sup>st</sup> and 2<sup>nd</sup> year) = 26957
6. Total Cost of Plantation per kilometer =  $8 \times 596874 = \text{Rs.} 4774992$
7. Total Cost of Plantation for 11.232 km =  $11.232 \times 4774992 = \text{Rs.} 53632710$

 Nursery cost of 26957 seedlings =  $51700 \times 26.957 / 1000 = 1393676$
