With reference to the above subject, the Ministry of Environment Forests and Climate Change, Government of India has accorded 'in principle' approval (Stage-I) under Section-2 of Forest (Conservation), Act-1980 for diversion of 53.67 ha forest land (originally proposed 75.92 ha) for Construction of Screening Plant, Tailing Dam, Slurry pipeline Corridor & Water Pipeline Corridor at Donimalai of M/s, National Minerals Development Corporation Limited, Donimalai, Sandur, (FC Online Application No. FP/KA/OTHERS/14576/2015) vide letter under reference(1).

The Principal Chief Conservator of Forests (Forest Conservation), Bengaluru has directed the User Agency to make payments (Net Present Value, CA and other charges) through e-payment module and submit Condition-wise Compliance Report in respect of all the condition stipulated in Stage-I approval vide letter under Ref(2).
