In continuation of this office endst. No. 11106 dated 21/02/2023 & your Ref. No. SHPBD/UA/07/2023 dated 06/04/2023 on the subject cited above.

2. In this context, you were allowed to change the name of user agency Bada Deo Small Hydel Projects Pvt. Ltd. 91/11 Chougan, Purana Bazar, Sundernagar with the condition No. 2 that "The user agency shall deposit transfer fee in CAMPA fund, to discourage middle men from processing applications and then selling it to other, @ 10% of NPV or Rs. 100,000 whichever is less."

3. The bill of transfer fee for change the name of user agency for diversion of forest land for the purpose mentioned above is raised as under:-
