With reference to the memo cited above on the captioned subject, it is intimate you that the financial out lay for Site Specific Wildlife Conservation Plan Pertaining to the above project amounting to Rs. 1,89,52,000 /- (Rupees One Crore Eighty Nine Lakh Fifty-Two Thousand) only has been approved by the PCCF (WL) & CWLW, Odisha, Bhubaneswar at the wage rate of Rs.308/- per man days with 10 years maintenance. This fund was deposited by you vide UTR No. SBINR 52021040920075267 dt.09.04.2021 & A/c No. 150826438533578 through RTGS.

Due to revision of wage rate from Rs.308/- MD to Rs.315/- MD the above financial outlay of Site-Specific Wildlife Conservation Plan approved by the PCCF (WL) & CWLW, Odisha, Bhubaneswar vide his memo under reference of Rs.2,02,24,440/- (Rupees Two Crore Two Lakh Twenty-Four Thousand Four Hundred Forty) only.
