I invite your attention to the references cited (copies enclosed) and inform that in the reference 1st cited the Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh, has furnished a statutory proforma proposal for diversion of 2.84 Ha of forest land in Compt.Nos. 138, 9 & 10 of Gollaguppa Extn –I RF & Bandirevu RF, Nellipaka Range, Chintur Division for formation and BT including construction of culverts to the road from R&B road to Gollaguppa (V) in favour of Executive Engineer, PR(PIU), Kakinada duly recommended in Part-IV and requested the State Government to place the proposal before a Committee constituted in the reference cited as per Government of India guidelines dated.15.02.2018, to accord Stage-I approval, as there are 240 trees to be felled in the area proposed for diversion and the value of the trees is Rs. 3,19,484/- and the area proposed for diversion falls in LWE District (i.e. East Godavari District).

- 2. Accordingly, the proposal was placed before the committee meeting held on 14.02.2019 under the Chairmanship of Principal Secretary to Government, EFS&T Dept. for its consideration. After detailed deliberations, the Committee 'recommended' the proposal with certain conditions for grant of Stage-I approval.
- 3. In the reference 4th cited, the Principal Chief Conservator of Forests & Head of Forest Force, was requested to furnish the proposal basing on the Minutes of the Meeting duly following the conditions, for taking further action in the matter.
- 4. In the reference 5th cited, the Principal Chief Conservator of Forests & Head of Forest Force, has furnished CA scheme to an extent of 2.88 ha with a financial outlay of Rs.28.671 lakh including maintenance of plantation for a period of 10 years commencing from 2022-23 to 2033-34 in the non-forest land identified by the User Agency in Thurnagi (V) of Kakinada Rural Mandal for compensatory afforestation. He has requested the State Government to take necessary action for onward submission of proposal to Government of India, Ministry of Environment, Forests & Climate Change, IRO, Vijayawada to accord forest clearance under Section-2 of Forest (Conservation) Act, 1980, as general approval in LWE areas has expired by 31.12.2020.
