As per the conditions stipulated in the stage-I approval letter issued by Regional Office you are advised to deposit the following requisite amount.


1. Cost of compensatory afforestation over 8.11 Ha. Non-Forest Land (Land allocated by Delhi Development authority at Village-Dhoolsiras, Dwarka New Delhi). Total Payable amount is Rs. 7,07,28,510 (Seven Crore Seven Lakh Twenty Eight Thousand Five Hundred Ten Only).

2. Cost of Net present Value @ 6,26,000 Per ha. for the Diversion of 8.11Ha. forest land, Total Payment amount is 50,76,860 (Fifty Lakh Seventy Six Thousand Eight Hundred Sixty Only).

3. Land to be handed over to the Department at earliest with demarcation pillars.  
The payment shall be deposit to CAMPA fund only through e-portal (<http://parivesh.nic.in>).


