It is to inform that, in the reference 30th cited, the Prl. Chief Conservator of Forests, AP, Mangalagiri informed that the vide reference 29th cited, the District Forest Officer, Nandyal has already issued demand notice and the same has been agreed by the Chief Conservator of Forests & Field Director, Project Tiger Circle, Nandyal. The demand notice uploaded by the user agency in Ministry's web portal has been examined and it is observed that the District Forest Officer, Nandyal has calculated NPV based on Eco-Class-III (Open forest) whereas in the site inspection notes, he has mentioned that density of vegetation varies from 0.2 to 0.4. As per the FSI, 0.2 density falls in 'Open' category whereas 0.4 density is treated as 'Dense' forest and each category has separate NPV rates.

Further, in the reference 31st cited, it is considered as dense forest as canopy density is 0.4 and that the revised demand notice with modified NPV rates of Dense forest was issued accordingly.

Amount demanded is to be deposited in "State CA Fund" of the Andhra Pradesh State through e-challan only.


Further the user agency is requested to deposit the value of tree extraction logging and transportation etc., in the forest area diverted as shown below and submit the payment receipt to this office.
