7. User Agency has submitted undertakings to defray the Cost of Compensatory Afforestation, Net Present Value and any increase thereof.
8. Compensatory Afforestation is proposed at 10.00 ha. degraded forestland at S.No.206 pt 5/1/1., Village-Vodisang, Ta.Kalavad Dist. Jamnagar. Scheme of Compensatory Afforestation is enclosed herewith.
9. Site inspection report of the Project area is provided by the concerned Deputy Conservator of Forest.
10. User Agency has applied to Collector, Jamnagar for the compliance under Forest Right Act, 2006. Application is attached.
11. Addl. Principle Chief Conservator of Forest(Land) and Nodal Officer(FCA), Gujarat State, Gandhinagar has recommended the proposal.
12.
