- 5. The User Agency will be liable to make good any loss to Forests/Environment caused to the the use of the said land by the user agency.
- 6. The User Agency will seek permission from the Roads & Buildings Department /Science and Technology Department, Sachivalaya, Gandhinagar.
- 7. The 66 kv cable will be laid underground in a trench of depth of 2.00mtr and width of 1.00 mtr in between rows of road side plantation.
- 8. Any other condition, which the Nodal Officer (FCA) may stipulate from time to time.
