Sub: Proposal for diversion of 28.67 ha of forest land for construction of 33 KV Transmission Line from Jang to Thingbu under Comprehensive Scheme for strengthening of T & D system in Tawang District of Arunachal Pradesh.

Sir,

This has got reference to the State Government's letter FOR. 789/CONS/2018/233-37 dated 08.02.2019, even no. 1286-87 dated 09.07.2019, even no.2508-09 dated 01.11.2019 on the subject mentioned above seeking prior approval of the Central Government under Section-2 of the Forest (Conservation) Act, 1980.

- 2. After careful examination of the proposal of the State Government and the recommendation of REC in its meeting held on 22.11.2019, *In-principle / Stage-I* approval of the Central Government is hereby granted for diversion of of **28.67 ha** of forest land for construction of 33 KV Transmission Line from Jang to Thingbu under Comprehensive Scheme for strengthening of T & D system in Tawang District of Arunachal Pradesh, subject to the following conditions:
- (1) Legal status of the forest land shall remain unchanged.
- (2) Compensatory afforestation shall be taken up by the Forest Department over double the area i.e. 57.35 ha degraded forest land identified at Kassin Putu (Ago) VFR under Hapoli Forest Division, Ziro at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.
- (3) An original notification declaring Kassin Putu (Ago) VFR as Village Forest Reserve in accordance of the provisions of the Arunachal Pradesh Anchal and Village Forest Reserve (Constitution and Maintenance) Act, 1975, as amended from time to time and the Assam Forest Regulation, 1891 may be submitted to this Regional Office of MoEF & CC, Shillong, prior to State-II approval.
- (4) The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and dwarf species plantation shall be deposited in the Compensatory Afforestation Fund of Arunachal Pradesh State managed by the Ad-hoc CAMPA, through E-portal in the account of the Ad-hoc CAMPA. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent

- (5) The State Govt shall charge the Net Present Value (NPV) for the 28.67 ha forest area to be diverunder the proposal from the Use Agency as per the orders of the Hon'ble Supreme Court of India da 30.10.2002, 01.08.2003,28.03.2008, 24.04.2008 and 09.05.2008 in IA No. 566 in Writ Petition (Ci No. 202/1995 and as per the guidelines issued by this Ministry vide its letter No. 5-1/1998-FC (P dated 18.09.2003, as well as letter No. 5-2/2006-FC dated 03.10.2006 and 5-3/2007-FC da 05.02.2009. The requisite funds shall be transferred through online portal to Ad-hoc CAMPA according to the State concerned.
- (6) Additional amount of NPV of the diverted forest land, if any, becoming due after finalization the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Commitshall be charged by the State Govt from the User Agency. The User Agency shall furnish undertaking to this effect.
- (7) All the funds received from the User Agency under the project towards compensatory leveies (and dwarf plantation cost, NPV, etc) shall be transferred/deposited to Compensatory Afforesta Fund of Arunachal Pradesh State managed by the Ad-hoc CAMPA only through e-portal mode.
- (8) The boundary of the diverted forest land shall be suitably demarcated on ground at the project c as per the directions of the concerned Divisional Forest Officer.
- (9) The charges for felling, logging and transportation of project affected trees should be colle from the User Agency at the rates approved by the State Govt and deposited with the DFO concertor utilization immediately following the diversion of forest land.
- (10) The expenditure like boundary walls, stone pillars, demarcation charges, cost of damage of t the funds on these accounts should, be deposited with the DFO concerned.
- (11) The User Agency shall restrict the felling of trees to minimum number in the diverted forest and the trees shall be felled under the strict supervision of the Satte Forest Department and the confelling of trees shall be deposited by the User Agency with the State Forest Department.
- (12) The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate the concerned District Collector.
- (13) The User Agency in consultation with the State Forest Department prepare a detailed scheme creation and maintenance of plantation of dwarf species (preferably medicinal plants) in right of under the transmission line for execution of the said scheme to the State Forest Department.
- (14) The User Agency at its cost shall provide bird deflectors, which are to be fixed on u conductor of transmission line at suitable intervals to avoid bird hits.
- (15) The User Agency shall comply with the guidelines for laying transmission through forest ϵ issued by Ministry vide letter no. 7-25/2012-FC dated 05/05/2014 & 19/11/2014.
- (16) The User Agency shall obtain the Environmental Clearance under Environment (Protection) 1986, if applicable.
- (17) The lay out of the proposal shall not be changed without the prior approval of the Ce Government.
- (18) No labour camps shall be established on the forest land.
- (19) Sufficient firewood, preferably the alternative fuel, shall be provided by the User Agency to labourer after purchasing the same from the State Forest Department or the Forest Develop: Corporation or any other legal source of alternative fuel.
- (20) No additional or new path will be constructed inside the forest area for transportatio construction materials for execution of the project work.
- (21) The period of diversion under this approval shall be co-terminus with the period of lease granted in favour of the user agency or the project life, whichever is less.
- (22) The forest land shall not be used for any purpose other than that specified in the project propo

- (23) The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
- (24) Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF & CC Guidelines F No. 11-42/2017-FC dated 29/01/2018.
- (25) Any other conditions that the North Eastern Regional Office, Ministry of Environment, Forest & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
- (26) The compliance report shall be uploaded on e-portal (https://parivesh.nic.in/)
- 3. After the receipt of the compliance report from the State Government on fulfillment of the conditions mentioned above, final/stage-II approval of the Central Government, in accordance with Section 2 of the Forest (Conservation) Act, 1980, will be considered. Till the receipt of the Final / Stage-II approval of the Central Government for diversion of the said forest land from this Ministry, transfer of the said forest land to the User Agency shall not be affected by the State Government.
