Revised Demand Notice

Sub:-APFD — Forest (C) Act, 1980 — Diversion of 4.96 ha of forest land in Compartment no 301, 322, 323 and 324 of Vedurawada II RF, Vizianagaram Division for formation of road from N.R. Puram to Gadiolova in favour of EE, PR Division, Paderu — In-principle (Stage-I) approval accorded — Orders communicated — Revised Demand notice issued - Request - Regarding.

In continuation of this office references 5th cited. It is informed that, in the reference 2nd cited, the Government of Andhra Pradesh have issued a memo where in the Government of India, MoEF & CC, IRO, Vijayawada have accorded in principal (Stage-I) approval for diversion of 4.96 ha of forest land for formation of road from N.R.Puram to Gadiolova in Compt. No. 301, 322, 323 & 324 of Veduruvada-II RF of Pedakonela beat, Bhimpolu Section of Paderu division (erstwhile Mentada section of Vizianagaram division) in favour of EE, PR Division Paderu subject to fulfillment of approval under section certain conditions as stipulated therein.

Fuurther, the Chief Conservator of Forests, Visakhapatnam has issued instructions to the revised demand notice called for in the reference 7th cited for the diversion of 4.96 ha of forest land for formation of road from N.R.Puram to Gadiolova in Compt. No. 301, 322, 323 & 324 of Veduruvada-II RF of Pedakonela beat, Bhimpolu Section of Paderu division (erstwhile Mentada section of Vizianagaram division) in favour of EE, PR Division Paderu.

Hence, the Executive Engineer, Panchayat Raj, PIU Division, Paderu is requested to go through the conditions stipulated from i to xxv in the GOI, MoEF&CC, IRO, Vijayawada Ir.F.no.4-APB204/2023-VIJ/997, dt.16.06.2023 as per reference 1st cited and also follow the instructions issued by the Pri.Chief Conservator of Forests (HoFF) A.P. Mangalagiri in the reference 3rd cited without any deviation as given below.

- 1) Publish the entire forest clearance granted in verbatim along with the conditions and safe guards imposed by the Central Government in two widely circulated daily newspapers, one in vernacular language and another in English language so as to make people aware of the permission granted to the project proponent for use of forest land for non-forestry purposes.
- 2) The copies of the Forest Clearance should also be submitted to the Heads of local bodies, Panchayats and Municipal Bodies by the project proponents in addition to the relevant offices of the Government who in turn have to display the same for 30 days.

As per the condition no (vii) the user agency shall pay the Net Present Value of the diverted forest land measuring 4.96 ha from the User Agency as per the orders of the Hon'ble Supreme Court dated 28.03.2008 and 09.05.2008 in IA Nos. 826 in 566 with related IA's in Writ Petition (Civil) No. 202/1995 and Ministry's guideline No. 5-3/2011-FC (Vol-I) dated 06.01.2022 and clarification issued vide letter dated 19.0.2022 and 22.03.2022.

As per the condition no viii) additional amount of the Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.

I. (a) Procedure for e- challan generation:

- On issue of this demand notice, the user agency shall log in to www.parivesh.nic.in to generate e-challan and make payment against the demand.
- Agency shall fill all the details as per the format provided in the portal and submit to Nodal Officer for verification.
- Once it is verified by Nodal Officer, Agency can generate e-challan from the portal.

I. (b) Procedure for Payment through RTGS:

- For payment through RTGS, the representative of the agency should visit his bank branch (RTGS enabled) of a Bank of his choice along with printed echallan with an Account Number printed on it.
- While tendering the e-challan at the bank, the agency must ensure that the unique account number mentioned in the challan should be correctly mentioned as the account number in which funds to be remitted.
- Upon executing the RTGS by the sender/ remitter bank, the amount collected will be credited to relevant CAMPA state account with the Bank on real time basis.


