Sub: Forests (Sanrakshan Van Evam Samvardhan) Adhiniyam, 1980 - Proposal (FP/TN/Road/151612/2022) for diversion of 0.768 ha of forest land with Carriage way @ 7.00m width and berm width @ 2.50m on either side for 640m length road lies in forest land of Ravathanallur Reserved Forests of Villupuram Forest Division for road expansion work on Vellimalai Moolakadu road between Pakkam and Ravathanallur villages across Ravathanallur Reserved Forest in Kallakuruchi District in favour of Assistant Divisional Engineer, Highways, Construction and Maintenance Sankarapuram Sub division, Sankarapuram, Kallakuruchi District – Forwarding of - Regarding.

I am directed to enclose a copy of the references 1st, 3rd and 5th cited. The Principal Chief Conservator of Forests (HoFF) in his letter first cited has stated that, the Assistant Divisional Engineer, Highways, Construction and Maintenance Sankarapuram Sub division, Kallakuruchi District has uploaded online forest clearance proposal for diversion of 0.768 ha of forest land in Ravathanallur Reserved Forest for road expansion work on Vellimalai Moolakadu road between Pakkam and Ravatanallur villages across Ravathanallur Reserved Forest in Kallakurichi District under the proposal No.FP/TN/Road/151612/2022.

- 2. In the Part-II of Form-A, the District Forest Officer, Villupuram Division has furnished the following details :
 - i). The legal status of the proposed site of diversion of 0.768 ha of forest land requested for the project is Reserved Forest and name of the forest land reported as Ravathanallur Reserved Forest.
 - ii). Density of the forest area is 0.2 and Eco class of forest area is five.
 - Species wise and girth class wise enumeration of trees in the area of 16 trees. These trees are planted as avenue trees by the Forest Department.
 - iv). On vulnerability of the forest area to erosion reported as the proposed site is undulating plain interspersed with hillock and thus prone to soil erosion.
 - v). Spotted deer, Jackal, wild boar black naped hare are present in and around the forest land proposed for diversion.

The forest area proposed for diversion is not part of National Park, Wildlife Sanctuary, Biosphere Reserve, Tiger Reserve, Elephant corridor, Wildlife migration corridor etc., and not located within the eco-sensitive zone of the protected area notified under Wildlife (Protection) Act, 1972 and not located within 1 km boundary of NP/WLS etc., for the forest land proposed for diversion. There is no rare / endangered / unique species of the flora and fauna found in the area.

- vi). There is no protected archaeological / heritage site / defense establishment or any other important monument is located in the area.
- vii). Requirement of forest land as proposed by the User Agency is unavoidable and bare minimum for the project.
- viii). No work in violation of the Act or guidelines issued under the Act has been carried out by user agency.
- ix). For the proposed diversion of 0.768 ha of forest land in Ravathanallur Reserved Forest for road expansion work on Vellimalai Moolakadupudur road between Pakkam and Ravathanallur village, compensatory afforestation has been proposed in 1.54 ha of degraded forest area in Thagarai Reserved Forest by planting of 1536 number of misc. seedlings along with maintenance of plantation over a period of 10 years at a cost of Rs.19,48,382/- and furnished the cost estimate of the Compensatory Afforestation scheme and area marked in the Survey of India topo sheet and surveyed sketch of the proposed Compensatory Afforestation area in geo-referenced map. Site suitability certificate of the Compensatory Afforestation area has also been furnished by the District Forest Officer.
- x). In the site inspection report and recommendation of the proposal, the District Forest Officer has stated the following:
 - a) This proposal is for diversion of 0.768 ha of forest land for road widening work on Vellimalai Moolakkadu pudur between Pakkam and Ravathanallur village across Ravathanallur Reserved Forest and the area inspected on 27.05.2022. There are 16 number of trees which are coming in the alignment and these trees planted as avenue trees by the Forest Department. It does not fall in the Elephant corridor. Diversion of forest area involved for 640m length and 12m width including the road existing portion.
 - b) Further, in the Essential details reply, the District Forest Officer, Villupuram has reported that this road was formed by the Highways Department prior to 1980 and maintained by them. As per the Reserved Forest notification, there is no right of way

allowed. On further clarification, the Principal Chief Conservator of Forests (HoFF) has stated that, the District Forest Officer has reported that, on perusal of road chart register of the division, it is seen that the said road was formed prior to 1980, hence the question of prior permission under provisions of the Forest (Conservation) Act, 1980 from the Forest Department does not arise and reply uploaded in the Essential details reply section.

The user agency has furnished the forest area diversion proposal for the entire width including the present road portion,

road expansion width proposed and berm portion.

xi). In the recommendation of the project proposal, The District Forest Officer has reported that, it is public project. The project is very useful to effective function of the public transport and hence recommended.

- 3. The Principal Chief Conservator of Forests (HoFF) has stated that the Conservator of Forests, Villupuram Circle has inspected the area on 09.07.2022 and he has recommended the project proposal involving diversion of forest land of 0.768 ha.
- 4. The Principal Chief Conservator of Forests (HoFF) has stated that the User Agency has requested forest area diversion for a period of 99 years. The District Forest Officer, Villupuram has recommended the project for the year 2022 and he has reported that it is an existing State Highway Road. Hence, he has recommended diversion of forest land for 50 years. The Conservator of Forests, Villupuram Circle has recommended the diversion of forest area for a period of 25 years.
- 5. The Principal Chief Conservator of Forests (HoFF) has further stated that State Government may accord diversion of forest land of less than one hectare in each case for non-forestry purposes under the Forest (Conservation) Act, 1980, for creation of critical development and security related infrastructure of Government Departments under the general approval of Forest (Conservation) Act, 1980 guidelines. In this case, Construction and widening of road is one of the work allowed under general approval list.
- 6. The Principal Chief Conservator of Forests (HoFF) has also stated that, the proposal is sent through parivesh portal duly recommended by the Additional Principal Chief Conservator of Forests (Forest Conservation Act) / Nodal Officer of Forest (Conservation) Act of the State of Tamil Nadu in Part-IV of Form-A.
- 7. Based on the recommendations of the District Forest Officer, Villupuram Division, Conservator of Forests, Villupuram Circle and Additional Principal Chief Conservator of Forests (FCA), the Principal Chief Conservator of Forests (HoFF) has recommended the proposal for diversion of 0.768 ha of forest land with Carriage way @ 7.00m width and berm width @ 2.50m on either side for 640m length road lies in forest land of Ravathanallur Reserved Forests of Villupuram Forest Division for road expansion work on Vellimalai Moolakadu road between Pakkam and Ravathanallur villages across Ravathanallur Reserved Forest in Kallakurichi District in favour of Assistant Divisional Engineer, Highways, Construction and Maintenance, Sankarapuram Sub division, Sankarapuram, Kallakurichi District for a period of 50 years, and requested to issue in-principle approval under general approval category as per the provision of guidelines under Forest (Conservation) Act 1980, subject to the following conditions:-

(i) The legal status of the diverted forest land shall remain unchanged.

(ii) The demarcation of the proposed forest land shall be carried out by the User Agency by erecting 4 feet high cement concrete pillars duly numbered at an interval of 20 meters at their cost.

(iii) The user agency has to pay the cost towards compensatory afforestation scheme over an extent of 1.54 ha of degraded forest area as per the Compensatory afforestation scheme including maintenance for a period of 10 years.

(iv) The User Agency has to pay the Net Present Value of proposed forests diversion area as per the guidelines of Hon'ble Supreme Court

of India /Government of India.

(v) The User Agency has to bear the additional amount of Net Present Value which will be fixed as per the guidelines of Hon'ble Supreme Court of India as fixed by Forest Department in future.

(vi) Amount of Compensatory afforestation scheme, Net Present Value of diverted forest area under the project shall be transferred/ deposited to

CAMPA fund only through e-portal (https://parivesh.nic.in/)

(vii) The User Agency has to pay the cost towards annual lease rent for the forest area diversion period as fixed by the Forest Department at the time of sanction along with any escalation for the forest land to be diverted of the above project in future for the entire project period.

(viii) The total forest area utilized for the project shall not exceed 0.768 ha for a length of 640 m and width of 12.0m (7.00m carriage way and 2.50m berm-shoulder on either side) in Ravathanallur Reserved

Forest.

(ix) The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies/department or person without prior approval.

(x) Period of lease can be fifty (50) years. The User Agency has to apply renewal proposal before one year of expiry of lease with the State

Forest Department.

- 8. As per of section 2 (1) of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and as per rule 9 of Van (Sanrakshan Evam Samvardhan) Rules 2023, approval of Government of India, Regional Office, Ministry of Environment Forests and Climate Change is required for diversion of forest land on lease.
- 9. On further clarification, the Principal Chief Conservator of Forest (HoFF) has stated that the above proposal has been submitted and processed in parivesh 1.00 module and in this module, there is no provision made in the web portal about prescribing scenario of proposal. However, as per the Van (Sanrakshan Evam Samvardhan) Rules, 2023, the approval for the proposal is to be issued by the Government of India. Hence he has requested that the proposal may be forwarded to the Government of India for issue of Stage-I approval for the project. Accordingly, the proposal is re-submitted by the Nodal Officer (FCA) through parivesh portal for obtaining approval of Government of India.
- 10. This proposal involves felling of 16 planted trees. Hence these 16 trees are transplanted under the supervision of the District Forest Officer, Villupuram Division instead of felling of the same. An additional condition is incorporated in this regard.
- 11. The Government have examined and accept the proposal (FP/TN/Road/151612/2022) of the Principal Chief Conservator of Forests (HoFF) for diversion of 0.768 ha of forest land with Carriage way @ 7.00m width and berm width @ 2.50m on either side for 640m length road lies in forest land of Ravathanallur Reserved Forests of Villupuram Forest Division for road expansion work on Vellimalai Moolakadu road between Pakkam and Ravathanallur villages across Ravathanallur Reserved Forest in Kallakurichi District in favour of Assistant Divisional Engineer, Highways, Construction and Maintenance, Sankarapuram Sub division, Sankarapuram, Kallakurichi District for a period of 20 years, under section

- 2 (1) of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980, subject to the following conditions and decided to recommend and forward the same to the Government of India, Ministry of Environment, Forests and Climate Change, Chennai for obtaining their concurrence:-
 - (i) The legal status of the diverted forest land shall remain unchanged.
 - (ii) The demarcation of the proposed forest land shall be carried out by the User Agency by erecting 4 feet high cement concrete pillars duly numbered at an interval of 20 meters at their cost.
 - (iii) The user agency has to pay the cost towards compensatory afforestation scheme over an extent of 1.54 ha of degraded forest area as per the Compensatory afforestation scheme including maintenance for a period of 10 years.
 - (iv) The User Agency has to pay the Net Present Value of proposed forest diversion area as per the guidelines of Hon'ble Supreme Court of India / Government of India.
 - (v) The User Agency has to bear the additional amount of Net Present Value which will be fixed as per the guidelines of Hon'ble Supreme Court of India as fixed by Forest Department in future.
 - (vi) Amount of Compensatory afforestation scheme, Net Present Value of diverted forest area under the project shall be transferred/ deposited to CAMPA fund only through e-portal (https://parivesh.nic.in/)
 - (vii) The User Agency has to pay the cost towards annual lease rent for the forest area diversion period as fixed by the Forest Department at the time of sanction along with any escalation for the forest land to be diverted of the above project in future for the entire project period.
 - (viii) The total forest area utilized for the project shall not exceed 0.768 ha for a length of 640 m and width of 12.0m (7.00m carriage way and 2.50m berm-shoulder on either side) in Ravathanallur Reserved Forest.
 - (ix) The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies/department or person without prior approval.
 - (x) The User Agency shall arrange for transplantation of 16 no. of planted trees in the project area under the supervision of the District Forest Officer, Villupuram Division instead of felling them.
 - (xi) Period of lease is twenty (20) years. The User Agency has to apply renewal proposal before one year of expiry of lease with the State Forest Department.
- 12. I am, therefore, directed to request you to kindly obtain the concurrence of the Competent Authority and communicate the same to this Government, early.

I wish to state that the Assistant Divisional Engineer, Highways, C&M, Sankarapuram Sub Division, Kallakuruchi District has uploaded forest clearance proposal under Section 2 of Forest (Conservation) Act, 1980 for diversion of 0.768 ha of forest land in Ravathanallur RF for road expansion work on Vellimalai Moolakadu road between Pakkam and Ravathanallur villages across Ravathanallur RF in Kallakuruchi District under proposal No. FP/TN/Road/151612/2022.

Brief details of the proposal are furnished below.

- i) The User Agency has uploaded the proposal in the prescribed format of Form A Part I under Section 2 of the Forest (Conservation) Act, 1980 for diversion of fresh forest area for an area of 0.768 ha.
- ii) Name and short narrative of the project for which forest land required reported as 'road expansion work by Highways Department, Construction and Maintenance, Sankarapuram Sub Division on Vellimalai Moolakadu road between Pakkam and Ravathanallur villages across Ravathanallur RF in Kallakuruchi District'.
- iii) The User Agency has reported that the area required in forest area is for 0.768 ha., and non-forest land required for the project reported as Zero ha.,
- iv) The User Agency has proposed the forest area diversion for the project for a period of 99 years.
- v) Name of the user agency reported as Highways Department, Construction and Maintenance Sankarapuram Sub Division, Kallakuruchi District and the incumbent officer of Assistant Divisional Engineer, C&M Sankarapuram Sub Division has submitted forest clearance proposal as person making application. Legal status of the User Agency reported as State Government.
- vi) The User Agency has uploaded a copy of autherisation issued by the Divisional Engineer, Highways Construction and Maintenance Kallakuruchi Division to the project proponent to furnish online application for getting forest clearance.
- vii) In the section of uploading details of proposal seeking prior approval of Central Government under the Act for diversion of forest land for the project already submitted in the past reported as NIL
- viii) Diversion of 0.768 ha of forest has been requested in Villupuram Forest Division area in erstwhile Villupuram District- presently area lies in Kallakuruchi District. Name of the village in which forest land requested has been reported as Rayathanallur.
- ix) The User Agency has furnished the component wise breakup details of land required for the project as linear for 0.768 ha of forest land requested for diversion to the project.

- x) Location map of the forest land proposed to be diverted in kml file of google earth, Scanned copy of Survey of India topo sheet indicating the proposed road alignment area marked in the map and Geo referenced map prepared along with GPS reading of the proposed linear stretch have been uploaded.
- xi) Note containing justification for locating the project in forest area has been furnished. The User Agency has stated that this project is site specific, hence no alternative have been examined.
- xii) The user agency has reported that permanent/ regular employment is likely to be generated for 10 persons and temporary employment likely to be generated to about 1500 numbers.
- xiii) The User Agency has stated that this project does not involve displacement of people due to the project, cost-benefit analysis for the project is not required and this project not requires clearance under the Environment (Protection) Act, 1986.
- xiv) The User Agency has stated that the project or part thereof is not located in any protected area or their Eco sensitive zone and not located in a Scheduled area.

- 5) The User Agency has requested forest area diversion for a period of 99 years. The District Forest Officer, Villupuram has recommended the project for the year 2022 and the Conservator of Forests, Villupuram Circle has recommended the diversion of forest area for a period of 25 years.

The District Forest Officer has reported that it is an existing State Highway Road. Hence diversion of forest land has been recommended for 50 years.

- 6) State Government may accord diversion of forest land of less than one hectare in each case for non- forestry purposes under the Forest (Conservation) Act, 1980, for creation of critical development and security related infrastructure of Government Departments under the general approval of Section 2 of Forest (Conservation) Act, 1980 guidelines. Construction and widening of road is one of the work allowed under general approval list.
- 7) Based on the recommendation made by the District Forest Officer, Villupuram Division and Conservator of Forests, Villupuram Circle, proposal received for diversion of 0.768 ha of forest land with Carriage way @ 7.00m width and berm width @ 2.50 m on either side for 640m length road lies in forest land of Ravathanallur Reserved Forests of Villupuram Forest Division for road expansion work on Vellimalai Moolakadu road between Pakkam and Ravathanallur villages across Ravathanallur RF in Kallakuruchi District seeking approval under Section 2 of Forest (Conservation) Act, 1980 by the Assistant Divisional Engineer, Highways, Construction and Maintenance Sankarapuram Sub division, Sankarapuram, Kallakuruchi District is furnished to the Government for consideration of the Government and following conditions is recommended for imposition of the project.

- i) The legal status of the diverted forest land remains unchanged.
- ii) The demarcation of the proposed forest land shall be carried out by the User Agency by erecting 4 feet high cement concrete pillars duly numbered at an interval of 20 meters at their cost.
- iii) The user agency has to pay the cost towards compensatory afforestation scheme over an extent of 1.54 ha of degraded forest area as per the Compensatory afforestation scheme including maintenance for a period of 10 years.
- iv) The User Agency has to pay the Net Present Value of proposed forests diversion area as per the guidelines of Hon'ble Supreme Court of India /Government of India.
- v) The User Agency has to bear the additional amount of Net Present Value which will be fixed as per the guidelines of Hon'ble Supreme Court of India as fixed by Forest Department in future.
- vi) Amount of Compensatory afforestation scheme, Net Present Value of diverted forest area under the project shall be transferred/ deposited to CAMPA fund only through e-portal (https://parivesh.nic.in/)
- vii) The User Agency has to pay the cost towards annual lease rent for the forest area diversion period as fixed by the Forest Department at the time of sanction along with any escalation for the forest land to be diverted of the above project in future for the entire project period.
- viii) The total forest area utilized for the project shall not exceeds 0.768 ha for with a length of 640 m and width of 12.0m (7.00m carriage way and 2.50 m bermshoulder on either side) in Ravathanallur RF.
- ix) The forest land proposed to be diverted shall under any circumstances be transferred to any other agencies/department or person without prior approval.
- x) Period of lease can be fifty (50) years. The User Agency has to apply renewal proposal before one year of expiry of lease with the State Forest Department.
- 8) The proposal is sent herewith duly recommended by the Additional Principal Chief Conservator of Forests (Forest Conservation Act)/ Nodal Officer of Forest (Conservation) Act, 1980 of the State of Tamil Nadu.

9) I request that the proposal may be considered and approval may be issued for diversion of 0.768 ha of forest land with Carriage way @ 7.00m width and berm width @ 2.50 m on either side for 640m length road lies in forest land of Ravathanallur Reserved Forests of Villupuram Forest Division for road expansion work on Vellimalai Moolakadu road between Pakkam and Ravathanallur villages across Ravathanallur RF in Kallakuruchi District seeking approval under Section 2 of Forest (Conservation) Act, 1980 in favour of the Assistant Divisional Engineer, Construction and Maintenance Sankarapuram Sub division. Highways, Sankarapuram, Kallakuruchi District for a period of 50 years.
