Adverting to the references cited above, it is submitted that vide reference 2nd cited, the Prl. Chief Conservator of Forests (HoFF) while enclosing stage-I approval accorded by the GOI, U/s 2 of Forest Conservation Act, 1980 for diversion of 0.0995 Ha of Forest Land in Medchal Division for Establishment of APCO 25 tower for Phase II Network in Greater Hyderabad Police Commissionerates in Medchal District in favour of Commissioner of Police, CyberabadCommissionerate subject to certain conditions stipulated therein and requested to submit the demand note to Nodal Officer (FCA) for vetting and only after vetting of the demand, the DFO should raise demand with the User Agency.

Further, vide reference 4th cited, Prl. Chief Conservator of Forests (HoFF),TS, Hyderabad has accepted the demand and requested to issue demand over the User Agency for deposition of funds into CAMPA account for NPV, CA etc and construction of Boundary Pillars, in DFO PD account.

As seen from the conditions stipulated by GOI, demand notice is to be issued to the User Agency for compliance of the following conditions:

- Condition No.2 The boundary of the diverted forest land shall be suitably demarcated on the ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
- 2. Condition No.4 The State Government shall charge the Net Present Value (NPV) for the 0.0995 ha forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30.10.2002, 01.08.2003, 28.03.2008, 24.04.2008 and 09.05.2008 in IA No.566 in WP (C) No..202/1995 and as per the guidelines issued by the Ministry vide letters No.5-1/1998-FC (Pt.II) dated 18.09.2003 as well as letter No.5-2/2006-FC dated 03.10.2006 and 5-3/2007-FC dated 05.02.2009 in this regard.

Cost of plantation (including ten years maintenance) for a minimum no. of 100 plants.

Therefore, the User Agency is requested to deposit an amount of Rs.3,83,687/-(Rupees Three lakhs eighty threethousand six hundred and eighty seven only) inTelangana State Compensatory Afforestation Fund Management and planning Authority (CAMPA). For this, the User Agency has to enter the details of demand notice raised in Ministry's web portal (parivesh.nic.in), which has to be vetted by the Nodal Officer, FCA, Telangana State and then the Challan to be generated and funds to be deposited against the account number mentioned in the Challan.

In addition, the User Agency is requested to deposit an amount of Rs.69,300/(Rupees Sixty nine thousand three hundred only) into the PD Account of District
Forest Officer, Medchalas mentioned above.

Further, the User Agency is requested to submit the compliance report on the conditions stipulated in the Stage-I approval to enable this office to submit the same to Head Office.
