With reference to the above subject, the Government of India and Government of Karnataka have accorded final (Stage-II) under Section-2 of Forest (Conservation), Act-1980 for diversion of 2.048 hectare (4.25 hectare as per Form A) of forest land in SM Block, Sandur South Range, Ballari District for Approach Road to ML No. 0005(ML No. 2313) in favour of M/s JSW Steel Ltd. Toranagallu vide letters under Ref(1) & (2).

In the light of approval accorded by the Government of Karnataka in their orders, the Principal Chief Conservator of Forests (Forest Conservation), Bengaluru has directed the Deputy Conservator of Forest, Ballari to execute an agreement with User Agency duly incorporating all the conditions imposed by the Government of India and Government of Karnataka subject to payment of any recoverable balance in compliance of the condition of Stage-I & Stage-II (final) vide letter under Ref(3).

Further, as per revised rates fixed in Consolidated Guidelines and Clarification issued under VAN (Sanrakshan Evam Samvaradhan) Adhiniyam, 1980 by the Government of India, Ministry of Environment, Forest and Climate Change (Forest Conservation Division), New Delhi, regarding applicability of revised rates of Net Present Value and stated that, "The new rates will also be applicable on all the cases that were granted Stage-I / in-principal approval prior to 06.01.2022 and where even after lapse of 5 years, the Stage-II / Final approval is not granted due to non-submission of complete compliance of the conditions stipulated in Stage-I / in-principal approval"
