A proposal ( three set hard copies) along with the required  
appendices, duly recommended is forwarded herewith for diversion of  
0.54 ha of forest land under section 2 of Forest (Conservation) Act, 1980  
for the construction of Vadakkumpadam Thampurattiparambu road in  
Thrissur Forest Division in favour of the Assistant Engineer, LSGD  
Section Pananchery Grama Panchayath for consideration and approval  
subject to the following conditions:-

1. Legal status of the forest shall remain unchanged.
2. The User Agency shall give undertaking to pay Net Present Value as per guidelines issued by Government of India.
3. The User Agency shall give an undertaking to pay additional Net

Present Value if required.

4. The User Agency shall not fell any trees or cause damage to the surrounding forest and shall take all possible measures to conserve tree growth.
5. The User Agency shall not use the forest land for any purpose other than the purpose for which the forest land is diverted.
6. When the forest land is no longer required for the purpose, the land will be resumed back to the Forest Department.
7. The User Agency shall abide by any other condition imposed later on by Government of India/Government of Kerala/ Forest Department in the interest of Forest Conservation.
8. The User Agency shall apply for renewal of approval after 10 years.
9. The User Agency has to sign an agreement with Divisional Forest Officer, Thrissur incorporating all the conditions imposed by Government of India/Government of Kerala/Kerala Forest Department in this regard and a nominal lease rent as decided by the Government of Kerala may be remitted.

The proposal has already been uploaded in the Union Ministry's web portal vide proposal No.FP/KL/Others/36446/2018. The approval of the Ministry of Environment and Forests may please be communicated to this office at the earliest.
