It is informed that the Government of India in the reference 1st cited has accorded In-principle (Stage-I) approval for diversion of 0.85 Ha of forest land falling in Compartment No:132, Mangalagiri Block, Tadepalli RF, Guntur Division for providing BT surface to the road from Brahmanandapuram Church to AIIMS road in favour of Municipal Commissioner, Tadepalli Municipality, Tadepalli subject to fulfilment of certain conditions. For fulfilment of the conditions, the user agency has to deposit the following amount.

I. (a) Procedure for e- challan generation:

- i. On issue of this demand notice, the user agency shall login to Forest Clearance portal **forestsclearance.nic.in** to generate e-challan and make payment against the demand.
- ii. Agency shall fill all the details as per the format provided in the portal and submit to Nodal Officer for verification.
- iii. Once it is verified by Nodal Officer, Agency can generate e-challan from the portal.

I. (b) Procedure for Payment through RTGS:

- iv. For payment through RTGS, the representative of the agency should visit his bank branch (RTGS enabled) of a Bank of his choice along with printed e-challan with an Account Number printed on it.
- v. While tendering the e-challan at the bank, the agency must ensure that the unique account number mentioned in the challan should be correctly mentioned as the account number in which funds to be remitted.
- vi. Upon executing the RTGS by the sender/ remitter bank, the amount collected will be credited to relevant CAMPA state account with the Bank on real time basis.

- II. Amount demanded for Tree extraction, logging and transportation in the forest area diverted to be deposited with Divisional Forest Officer (As per IGF , Adhoc CAMPA Ir.No. 13-20/2015 CAMPA dated : 09-06-2016 communicated vide PCCF 's Rc. No. 45921/2001/FCA-4 (ii), dated : 04-07-2016)
