Sub:- Proposal for diversion of 9.441 ha. of forest land in Lamdunguri RF for construction of Additional Spillway of Hirakud Dam Project, Burla in Sambalpur District in the State of Odisha (Proposal No.FP/OR/IRRG/2016)- Demand for the payment of differential amount of Compensatory Afforestation scheme @Rs.326/-MD.

In continuation to this office memos under reference and the Stage I approval order, Compensatory Afforestation scheme was technically approved @Rs.280/- mandays and the said differential amount was deposited by you on dt.04.05.2019. Thereafter again the revised differential CA cost @Rs.315/Manday amounting to Rs.19,77,000/- was demanded vide Memo No.2287 dt.13.04.2022 of this office, which has not been deposited by you. But by mistake we had mentioned in our letter No.5056 dt.26.08.2022 that the previously raised demand of Rs.44,76,000/- has been deposited by you which was wrong. Hence the revised financial outlay with detailed cost break up for the approved CA at the current wage rate of Rs.326/- per manday is furnished below for necessary action at your end.
