On the above mentioned subject under reference, it is to inform you that the **Stage-I in-principle** approval order in connection with the above project has been issued vide No. 5-ORC548/2023-BHU dt.17.02.2023 Govt. of India, MoEF and CC, IRO, Bhubaneswar with 29 conditions and additional 07 conditions has been imposed by the State Government vide No.FE-DIV-FLD-0009-2023-10F(Cons)07/2023-1298/FE&CC dt.21.01.2023 of the Government of Odisha, Forest Environment & Climate Change Department which has been communicated to you vide Memo No.1302/FE&CC dt.21.01.2023 of the OSD-cum-Special Secretary to Government, Forest Environment & Climate Change Department which may be referred to.

As per Condition No. A(iii) & B(ii) in the **Stage-I in-principle** approval order, 12.523 Ha. of Degraded Forest Land has been identified in Kapilash RF under Kapilash Wildlife Sanctuary Area of Sadangi Range of Dhenkanal Forest Division for Compensatory Afforestation purpose. Accordingly the financial outlay for Compensatory Afforestation Scheme over 12.523 ha. of degraded forest land identified in Kapilash RF (Kapilash Wildlife Sanctuary) under Sadangi Range in **Dhenkanal Forest Division** against proposed division of the above mentioned project has been approved for **Rs.83,44,900/-** (Rupees eighty three lakhs forty four thousand and nine hundred) only by PCCF (Forest Diversion and Nodal Officer, FC Act.) O/o the PCCF, & HoFF, Odisha, Bhubaneswar as per **approved onetime cost norm** vide his Memo No.4060/9F(Pipeline)390/2022 dt.02.03.2023 and communicated to you vide his Memo No.4064 dt.02.03.2023 which may be referred to.

As per Condition No.A(i) & B(iii) in the **Stage-I in-principle** approval order, the State Government shall charge the Net Present Value (NPV) for the Forest Land proposed for diversion.

- 1. Forest area to be diverted for non-forest purpose -2.3140 Ha.
- 2. Density of vegetation -Eco value class-III, 40% dense forest
- 3. Demand for NPV-Rs.12,28,590/- x 2.3140 Ha. = Rs.28,42,957/-

In view of the above facts, it is requested to transfer/deposit of the following amounts in CAMPA account only through e-portal (<u>https://parivesh.nic.in/</u>) along with furnish an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India.

## Compensatory Afforestation = Rs.83,44,900/ NPV = Rs.28,42,957/

As per Condition No.A(viii) in the Stage-I in-principle approval order, it is requested to please take immediate steps for obtaining FRA Certificate from the Collector, Dhenkanal immediately.

Further, it is to inform you that, since it is liner project and after full realization of funds for Compensatory Afforestation and Net Present Value (NPV), the Divisional Forest Officer, Dhenkanal Division duly authorized in this behalf by the State Govt. can pass an order for tree cutting and commencement of work of a linear project in forest land for a period of one year which can be extended for a period of one year subject to submission of satisfactory compliance of conditions stipulated in the Stage-I approval as per guidelines issued vide F. No.7-5/2022-ROHQ(Pt) dt.26.08.2022 of Govt. of India, MoEF & CC, (ROHQ), New Delhi communicated vide Memo No.20868/9F(Misc)-111/2014 dt.14.10.2022 of the Conservator of Forests (Nodal), O/o the PCCF & HoFF, Odisha, Bhubaneswar.

Therefore, it is requested to please submit the deposit particulars / receipt along with compliance report of 29 conditions imposed in the Stage-I **in-principle** approval order and additional 07 conditions imposed vide Letter No. FE-DIV-FLD-0009-2023-10F(Cons)07/2023-1298/FE&CC dt.21.01.2023 of the Government of Odisha, Forest Environment & Climate Change Department in 05 copies through booklet in both hard and soft copies to this office immediately for further action at this end.
