It is submitted that, the State Govt. vide reference 1st cited has accorded stage -I approval for Diversion of Forest land to an extent of 2.0025 ha in various forest divisions viz Gudur WL (1.362 ha), Mahabubabad (0.131 ha), Yellandu (0.344 Ha) Warangal (Rural) (0.1655 ha) in Mahabubabad, Kothagudem and Warangal (Rural) Districts respectively for laying of optical Fiber Cable along the road and in favour of M/s Jio Digital Fiber Private limited (Earlier M/s Reliance Jio Infocomm Limited), subject to fulfillment of certain conditions stipulated therein. which has been communicated in ref 2nd cited by the PrI.CCF(HoFF) for raising of demand notice to user agency for making payment of compensatory levies in consultation with the Nodal Officer (FCA) and to obtain the compliance report on the conditions stipulated by the MoEF& CC, GoI, from the user Agency and furnish through Chief Conservator of Forests , Kothagudem for obtaining Stage II (final) approval.

In compliance of the above instructions, draft demand notice is prepared and vetted from the PCCF, TS, hyd in the reference 3rd cited above. The details are as follows.

Further, the User Agency will be directed to deposit an amount of **Rs.2,15,400 (Rupees Two Lakhs fifteen thousand four hundred only)** in the Telangana State Compensatory Afforestation Fund Management and Planning Authority (CAMPA) saving bank Account maintained in the Corporation Bank, CGO Complex, Lodhi Road, New Delhi-110003, **through online mode only, through e-portal method at MoEF&CC, GOI, New Delhi portal i.e., <http://parivesh.nic.in> by generating the challan in consultation with Nodal Officer, Telangana State Forest Department. The user agency needs to upload the demand notice against the project for approval by Nodal Officer (FCA), Telangana and generate challan after approval. The payment to be made against the Challan number and the Challan is valid for one week. A step-by-step process is available at <http://parivesh.nic.in>**

The User Agency has to deposit an amount of **Rs.6,13,000/- (Rupees Six Lakh Thirteen Thousand only)** into the **PD Account of Forest Divisional Officer, Yellandu**, as given above.

Further, the User Agency has to comply with following in accordance with the MoEF&CC, GoI instructions issued vide F.no.7-23-2012-FC, Dt.24.07.2013 communicated vide Prl. Chief Conservator of Forests, A.P Hyderabad Rc.45921/2001/F4, Dt.23.08.2013:

1. Publish the entire forest clearances granted in verbatim along with the condition and safe-guards imposed by the Central government in two widely circulated daily newspaper one in vernacular language and the other in English granted to the project proponent for the use of forest land for the non-forest purposes.
2. The copies of the forest clearance should also be submitted to the heads of local bodies, Panchayats and municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.

The user agency will be requested to comply with the other conditions as directed in ref 1st and 2nd cited and submit the compliance report along with all the required relevant information/documents etc. on the conditions stipulated by Govt. In Stage I approval for obtaining Stage II (final) approval.

The user agency is requested not carry out any work in violation of the FC Act 1980 and wildlife (protection) Act, 1972 without receipt of final clearance from the competent authority. Further transfer of Forest land to User Agency shall not be effected prior to the issue of final (Stage-II) approval or working permission.
