In compliance to the instructions issued vide references cited above, It is submitted that, the Government of India, Ministry of Environment, Forests & Climate change, Integrated Regional Office, Hyderabad vide reference 11th cited above has accorded in principle (Stage-I) approval for Diversion of **2.2745 Ha (Revised from 3.2493 Ha) of forest Land** for laying of BT Road from **MRL-01- Nennel to Kushnepally** via Konampet of Chennur RF of Kushnepally Range of Bellampally Division of Mancherial district in favour of District Panchayath Raj Engineer (PIU) Mancherial subject to certain conditions stipulated there in and the same has been communicated by the Prl. Chief Conservator of Forests TS Hyderabad vide reference 12th cited and requested to prepare comprehensive wildlife mitigation plan in compliance to condition no.6 of stage I approval and submit the same to Principal Chief Conservator of Forests & CWLW for approval.

Further, the Principal Chief Conservator of Forests TS Hyderabad vide reference 14th cited above has approved Wildlife Mitigation Plan for an amount of Rs.12.50 lakhs and requested raise the demand with the User Agency.

Accordingly, the assessment are made towards issuing of Demand Notice to the User Agency is furnished hereunder.

The User Agency shall deposit an amount of **Rs.15,31,930/- (Rupees Fifteen Lakhs Thirty One thousand Nine hundred Thirty only)** in favour of Forest Divisional Officer, Bellampally PD A/c No. 37110004892, State Bank of India, Branch: Bellampally, IFSC: SBIN0020120.

Further, the User Agency will also be requested that, the user agency shall compulsorily deposit an amount of **Rs. 21.78471 Lakhs** pertains to NPV, into Telangana State Compensatory Afforestation Fund Management and Planning Authority (CAMPA) saving bank Account through the Ministry's Website i.e., <http://parivesh.nic.in> by generating the challan in consultation with the Nodal Officer (FCA) O/o Principal Chief Conservator of Forests, TS, Hyderabad. The user agency needs to upload the demand notice against the project for approval by Nodal Officer (FCA), Telangana and generate challan after approval. a	Compensatory afforestation shall be taken up by the Forest Department over 2.2145 ha of non-forest area out of 39.84 ha of non-forest area identified in Sy No BDPP of Indhani Village of Karameri Mandal of Karameri Range of Asifabad, at the cost of the User Agency. A mixture of local indigenous forestry species shall be planted and monoculture of any species may be avoided.	<i>The non forest land for CA is falling KB-Asifabad Dist. b	In addition to the plantation in identified non forest land, compensatory afforestation (i.e., balance numbers of plants) shall be carried out over apportioned extent of area within the 40 ha of degraded forest area identified in Compt. a	The State Government shall charge the Net Present Value (NPV) for 2.2745 ha forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/OB12003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in Wp (C) No.2021t995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No. 5-212006-FC dated 03/11/2006, 5-312007-FC dated 05/02/2009 and 5-3/2011t-FC dated 06-01-2022 in this regard (NPV charges @ 9.57780 Lakhs per Ha. Eco-class-III Considering of Tropical Dry Deciduous Dense Forest (2.2745 Ha. X 9.57780 Lakhs = Rs.21.78471/-)	21.78471

Further, the User Agency will be requested to ensure that, animal passages shall be constructed as per the design and dimensions prescribed by WII, Dehradun at 5 locations indicated by Forest Department and also convert all existing causeways into box culverts for easy and safe passages of wild animals.

Further, the User Agency will be requested to intimate the details of payments made and submit seven sets of compliance report on all the conditions stipulated in Stage-I approval along with all the necessary documents, certificates, undertaking etc., for onwards submission to the competent authority for issue Stage-II approval.

The User Agency is requested to comply with the following accordance with the Government of India instructions issued vide F.No.7-23/2012-FC, Dt.24.07.2013 communicated vide PCCF's Rc.No.45921/2001-F4, Dt.23.08.2013 and publish the orders at the cost of the project proponent.

1. Publish the entire forest clearance granted in verbatim along with the conditions and safeguards imposed by the Central Government in two widely circulated daily newspapers, one in vernacular language and the other in English language, so as to make people aware of the permission granted to the project proponent for use of forest land for non-forest purpose.
2. The copies of the Forest Clearance should also be submitted to the Head of local bodies, Panchayats and Municipal Bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same in 30 days from the date of receipt of this reference.

Further, the User Agency will be requested to furnish undertakings on C. No.1,4(b),5,7,8 to 19.21 to 23.

The transfer of forest land to User Agency shall not be affected prior to the issue of final (Stage II) approval or working permission. The demand notice for CA NFL & DFL will be issued separately by the District Forest Officer, KB-Asifabad.
