The demand notice is prepared pertaining to Kamareddyand Banswada Divisions of Kamareddy district and as per the conditions stipulated; the User Agency (UA) has to make the payment towards the following compensatory levies:

The UA shall ensure that felling of trees shall be done under the supervision of the forest department wherever necessary at the project cost as prepared by the concerned DFO/FDO (C.No. vi).

The layout plan shall not be changed without the prior approval of the Central Government (C.No.xiii).

The UA shall ensure that No. additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work (C.No. xvii).

The user agency at its cost shall provide bird flight divertors as per the specification of GoI, Ministry of Power, Central Electricity Authority in F.No. CEA-PS-14-75/1/2019-PSETD Diversion/624-87, Dt. 10.11.2021, issued in pursuance to Hon' ble Supreme Court of India orders on transmission line to avoid chances o collision of birds to the transmission lines, which are to be fixed on upper conductors of transmission line at suitable intervals (C.No. x, xi)

The US shall comply with all other conditions stipulated in the Stage-I (inprinciple) approval, Part II to IV and the covering letters etc.

The UA is informed that as per the guidelines issued by MoEF & CC, GoI (Adhoc CAMPA Wing), the mode of remittance for compensatory levies shall be through e-payment portal of Ministry of Environment, Forest & Climate Change only, The Superintending Engineer, Lift Irrigation Schemes, TSTRANSCO, Karimnagar circlehas to upload the demand notice received in the Ministry's portal against the project for approval by the Nodal Officer, FCA, Telangana State. Then challan has to be generated and payment to be made against the bank account number indicated in the challan. Amount deposited through other mode will not be accepted. The detailed procedure for generation of Challan and deposition of funds is available at www.parivesh.nic.in portal. The other amounts as per demand notice shall be deposited into concerned DFO/FDO PD account.

The UA shall comply with the following in accordance with the MoEF &CC, GoI instructions issued vide F.no. 7-23-2012-FC, dt.24-07-2013 communicated vide Prl. Chief Conservator of Forests, A.P. Hyderabad Rc No. 45921/2001/F4,dt.23-08-2013.

- Publish the entire forest clearances granted in verbatim along with the condition and safe-guards imposed by the Central government in two widely circulated daily newspaper one is vernacular language and the other in English granted to the project proponent for the use of forest land for the non-forest purposes.
- The copies of the forest clearances should also be submitted to the heads of local bodies, Panchayats and municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.

The transfer of forest land to user Agency shall not be affected prior to the issue of final approval Stage II Clearance or issual of working permission and no work in violation shall be carried out.

The UA is also requested to note the other conditions stipulated and implemented and furnish the compliance on the conditions stipulated to concerned District Forest Officer for submission through Chief Conservator of

Forests/Conservator of Forests for onward submission to Government for obtaining Stage-II approval.

Further, the user agency will be requested to furnish compliance report along with all the required relevant information/documents etc. as stipulated in Stage-I approval and other conditions at the earliest, so as to submit the condition wise compliance report to the higher authorities for obtaining Stage-II approval.

With reference to the subject cited above it is submitted that, the Principal Chief Conservator of Forests (HoFF), Telangana State, Hyderabad vide reference 9th cited above, has forwarded the Stage-I (in-principal) approval accorded for diversion of Forest Land for the subject project in the reference 8th cited with condition stipulated therein and requested to submit the Demand Notice for payment of compensatory levies to be paid by the Executive Engineer, Lift Irrigation Schemes, TSTRANSCO, Nizamabad Dist (User Agency) in consultation with the Nodal Officer (FCA) and obtain the compliance report from the user agency and furnish to obtain final (Stage-II) approval from the Government.

The User Agency is requested to make the payment of Net Present Value (NPV), Cost of CA, Cost of Construction of Boundary Pillars, Raising of Dwarf Medicinal Plantation, Translocation of trees, Extraction of tree growth and issue the Demand Notice to the User Agency only after vetting by the Nodal Officer.

The User Agency will be directed to deposit the compensatory levies towards CA, NPV etc. into the Telangana State Compensatory Afforestation Fund Management and Planning Authority (CAMPA) saving bank Account maintained in the Corporation Bank, CGO Complex, Lodhi Road, New Delhi-110003, through online mode only, through e-portal method at MoEF&CC, GOI, New Delhi portal i.e., http://parivesh.nic.in by generating the challan in consultation with Nodal Officer, Telangana State Forest Department. The user agency needs to upload the demand notice against the project for approval by Nodal Officer (FCA), Telangana and generate challan after approval. The payment to be made against the Challan number and the Challan is valid for one week. A step-by-step process is available at http://parivesh.nic.in.

In addition to the Stage I conditions, as per the MoEF & CC, GoI instructions issued vide F.No. 7-23-2012-FC, Dated 24-07-2013, the User Agency shall,

The user agency is requested to furnish compliance report alongwith all the required relevant information / documents etc. as stipulated in reference 8th and 9thcited in Stage-I approval at the earliest, so as to submit the condition wise compliance report to the Concerned FCA Authorities for obtaining Stage-II approval. The transfer of forest land to User Agency shall not be affected prior to the issue of final (Stage II) approval or working permission.
