
With reference to the above cited letter on the subject, it is to inform that the Govt. of India Ministry of Environment, Forest & Climate Change Integrated Regional Office, Chandrasekharpur, Bhubaneswar vide their letter No. No. 5-ORA466/2021-BHU dt. 03.12.2021 have accorded in principle approval under section -2 of the Forest (Conservation) Act ,1980 for diversion of 125.355 ha (Reserve Forest land 41.533 ha Protected Forest 23.326 ha Revenue Forest (Village Forest 60.496 ha) of forest land for the construction of Angul- Gopalprased-Puttagadia-Jarapada-Tentuloi New BG Railway Line by East Coast Railways.

The revised scheme for Compensatory Afforestation land over an area 251.00 Ha. identified degraded forest land located at Bhimkhol RF of Saintala Range under Balangir Forest Division ~~in~~ has been technically approved by the Principal Chief Conservator of Forests, Forest Diversion & Nodal Officer, F.C. Act vide his memo No. 11116 dt. 01.06.2022.

In view of the above, the wage rate of the above financial outlay of CA scheme has been revised at the wage rate of Rs. 326/- per MD and approved by Chief Conservator of Forests (FD & NO, FC Act.) for Rs. 4,30,53,200/- (Rupees Four Crore thirty lakhs fifty three thousand two hundred) only.

Hence, you are requested to deposit the additional CA amount of **Rs. 37,12,000/- (4,30,53,200 - 3,93,41,200** already deposited on dt. 17.01.2022) (Rupees Thirty Seven Lakh Twelve Thousand only) in the. **Ad-hoc CAMPA in the saving Bank Account No. 520101263743655 , Corporation Bank, Lodhi Complex, Ground Floor, Block No. 11, CGO Complex, Lodi Road New Delhi** through "e" payment immediately and intimate the same to the undersigned for taking further action in the matter.




With reference to this office memo on the subject cited above, it is to inform you that the financial outlay for CA Scheme over an area 251.00 ha of degraded forest land identified in Bhimkhoh RF of Saintal Range under Bolangir Forest Division pertaining to the above project amounting to Rs. 3,93,41,200/- (Rupees Three Crore ninety-three lakh forty one thousand two hundred) only approved at the wage rate of Rs.315/- per man day with 10 years maintenance.

Due to enhancement of wage rate the above financial outlay of CA scheme has been revised at the wage rate of Rs.326/- per MD and approved by Chief Conservator of Forests (FD & NO, FC Act) for Rs. 4,30,53,200/- (Rupees Four Crore thirty lakhs fifty three thousand two hundred) only. The approved financial outlay for the above scheme is enclosed herewith for information and necessary action.

In view of above, DFO, Angul is requested to raise demand of differential amount of Compensatory Afforestation to the User Agency to deposit through PARIVESH web portal of MoEF & CC and submit the deposit particulars of the amount paid. The details of deposit made by the UA in respect of this project in the prescribed CAMPA format duly signed by you alongwith Stage-I compliance is to be submitted.


