**Brief Description:** 

The user agency has proposed diversion of 0.69 ha of Forest Land for construction of Playground at 15th Mile J.N. Road, Kyongnosla in Gangtok district of Sikkim by Sports & Youth Affairs Department, Govt. of Sikkim, after obtaining the forest clearance under the provision of Forest (Conservation) Act, 1980.

The proposal has since been uploaded in the "OMFC" portal of the Ministry vide proposal No. FP/SK/OTHERS/146127/2021 and accordingly transferred to the level of MoEF, Integrated Eastern Regional Office at Kolkata through on-line mode.

the above identified forest land is enclosed at Annexure -II for reference.

The aforesaid degraded forest land is proposed to be brought under Afforestation programme as per the Compensatory Afforestation Scheme drawn by the Divisional Forest Officer, Gangtok Territorial Division with financial outlay of Rs. 3,39,667.00 (Rupees three lakhs thirty-nine thousand six hundred sixtyseven) only (Enclosed at Annexure III). The Compensatory Afforestation Scheme will be undertaken in the designated compact area identified by Gangtok Territorial Division of Sikkim.

The Divisional Forest Officer (T) Gangtok Division has given the certificate on suitability of degraded forest land for Compensatory Afforestation. (Annexure –IV). Accordingly, the User Agency has furnished an undertaking to deposit the amount of CA, NPV and additional NPV if any etc. (Annexure – V), after Stage I clearance is granted by the Ministry in this respect. But no Penal Compensatory Afforestation has been imposed since no violation of the Act has been reported against.
