The Executive Engineer, Panchayat Raj (PIU), Vizianagaram is aware that the Government of India in the reference 1st cited have accorded in principle Stage-I approval for diversion of 3.37 hectares of Forest land for formation of road proposed from Vetaganivalasa to Tangalam in Pachipenta mandal, Mathumuru beat of Saluru Section/ Range, Vizianagaram Forest Division in favour of Executive Engineer, Panchayat Raj (PIU), Vizianagaram with conditions to pay N.P.V. C.A., to Adhoc CAMPA account to A.P. Forest Department.

In this connection, the user agency has to pay the cost of Net present value and Cost of Compensatory afforestation as per the conditions stipulated in the stage-I approval accorded by the Government of India. Hence, a demand notice is prepared as per the instructions issued by the Prl. Chief Conservator of Forests, A.P. Guntur in the reference 3rd cited and enclosed herewith to transfer/remit Rs.54.69 lakhs to Adhoc CAMPA account and submit counterfoils to this office for further process.

It is further requested to furnish the condition wise compliance report for the Stage-I approval accorded by the Government of India, M.o.E.F, I.R.O., Vijayawada vide F.No.4-APB170/2022-VIJ/398, dt: 07.06.2022 and also for the following conditions as per the instructions issued by the Government of India in F.No.7-23/2012-F.C.Act, 1980, dt: 24.07.2013 communicated in PCCF. Rc.No.45921/2001/F4, dt: 23.08.2013. Copy of Government of India IRO, Vijayawada letter F.No.4-APB170/2022-VIJ/398, dt: 07.06.2022 and Prl.C.C.F., A.P. Guntur Rc.No.EFS02-15034/11/2021-FCA-SEC-PCCF/FCA-3, dated: 05.07.2022 are enclosed herewith.

1. Publish the entire forest clearances granted in verbatim along with the conditions and safeguards imposed by the Central Government in two widely circulated daily newspapers one in vernacular language and another in English language, so as to make people aware of the permission granted to the project proponent for use of forest land for non forestry purposes.
2. The copies of the Forest clearance should also be submitted to the Heads of local bodies, Panchayats and Municipal Bodies by the project proponents in addition to the relevant offices of the Government who in turn have to display the same for 30 days.

The compliance for the above conditions shall be submitted to this office immediately, so as to submit the same to the Prl. Chief Conservator of Forests, A.P. Guntur through Chief Conservator of Forests, Visakhapatnam to get the final approval at the earliest.

The Executive Engineer, Panchayat Raj (PIU), Vizianagaram is aware that the Government of India in the reference 1st cited have accorded in principle Stage-I approval for diversion of 3.37 hectares of Forest land for formation of road proposed from Vetaganivalasa to Tangalam of Pachipenta mandal in Vizianagaram Forest Division in favour of Executive Engineer, Panchayat Raj (PIU), Vizianagaram with conditions to pay Net present value and C.A., to Adhoc CAMPA account.

In this connection, as per the conditions stipulated in the stage-I approval and as per the instructions issued by the Prl. Chief Conservator of Forests, A.P. Guntur in the reference 3rd cited, the Executive Engineer, Panchayat Raj (PIU), Vizianagaram is requested to transfer or deposit the following amounts to CAMPA fund only through e-portal (<https://parivesh.nic.in/>) in connection with the diversion of 3.37 hectares of Forest land proposed for formation of road from Vetaganivalasa to Tangalam.

I (a) Procedure for e-challan generation:

- i. On issue of this demand notice, the user agency shall log into Forest clearance portal **forestsclearance.nic.in** to generate e-challan and make payment against the demand.
- ii. Agency shall fill all the details as per the format provided in the portal and submit to Nodal Officer i.e., Prl. Chief Conservator of Forests, A.P. Guntur for verification.
- iii. Once it is verified by Nodal Officer, Agency can generate e-challan from the portal.

I (b) procedure for payment through RTGS:

- iv. For payment through RTGS, the representative of the agency i.e., Executive Engineer, Panchayat Raj (PIU), Vizianagaram should visit his bank branch (RTGS enabled) of a Bank of his choice along with printed e-challan with an Account Number printed on it.
- v. While tendering the e-challan at the bank, the agency must ensure that the unique account number mentioned in the challan should be correctly mentioned as the account number in which funds to be remitted.
- vi. Upon executing the RTGS by the sender / remitter bank, the amount collected will be credited to relevant CAMPA state account with the Bank on real time basis.

Further, it is informed that if any payment is made by any other method, the same shall not be considered for compliance towards Stage-I/II as per the guidelines issued in IGF, Ad-hoc, CAMPA, Lr.No.12-2/2010-CAMPA, dt: 14.04.2017.
